a. Budget Workshop

Director Anastasia presented the changes to the proposed FY 2021-2022 Budget as discussed at previous meetings for further consideration and discussion. Board discussion ensued.

a. Staff

Director Magdziarz reported that he is hopeful the Prairie Grove Commons proposed development at Galena and 47 will move forward soon. He stated that he was contacted regarding building a retail space at Lot 17 of Sugar Grove Commons, the Landings Office Park is actively being marketed for medical use, and he was contacted regarding the vacant lot of Harter Drive south of Connor Plumbing. CMAP has not yet selected a consultant for the Comprehensive Plan Update.

Director Special reported that the kick-off meeting for the Pavement Management Analysis by CMAP will be held this Thursday. The Kane County Road Impact Fee committee is meeting to review County impact fees. Progress is being made on Well #10 and it should be completed by the end of the week. Eighty percent of the road salt allocation has been ordered and received. PW staff is analyzing the need for more. Trustee Koch asked how long the culvert improvements on Bliss Road would take. Director Special responded that the County has stated that it will take four months.

Administrator Eichelberger reported that the letter regarding the Elburn Boundary Agreement was sent. Elburn staff has indicated a response is not likely until at least April. Trustee Konen asked about the anticipated timeline for the removal of topsoil

from the Hannaford Farm pile by current builders. Administrator Eichelberger indicated it is estimated to be next week, weather dependent.

Director Anastasia reported that he is still awaiting information from the Treasury regarding the last COVID federal funds.

Chief Rollins reported that it has been a quite couple of weeks in the Village, but that neighboring communities are still experiencing auto burglaries. Residents are encouraged to lock car doors in their driveways and close garage doors.
