a. Resolution: Authorizing Purchase of LED Replacement Streetlights

A motion was made by Trustee Schomas, seconded by Trustee Herron, to approve a resolution authorizing the purchase of LED Street Light Retrofit Kits in the amount of \$17,889.98 from City Electric Supply. The motion carried by the following vote:

Director Speciale explained that staff applied for the ComEd Energy Efficiency Program Incentive to convert all the Street lights to LED within the Windsor Point Subdivision for a total of 59 street lights. In addition to a decrease in energy consumption and lighting maintenance costs, the Village will see savings in longer light lifespan over current bulbs. The LED Street Light Retrofit Kits would be installed in house by Public Works staff. This will be a pilot program that is expected to expand if successful. Board discussion ensued.

#### a. Staff

Director Speciale reported that the CMAP Pavement Management Assessment was moving forward with the van scheduled to be in the area shortly. A draft report is expected in June. The 2021 MFT Road Program will begin next week.

Administrator Eichelberger reported that staff is still looking to fill the Deputy Village Clerk position and that the Village has received an application for the Prairie Grove Commons development at IL 47 and Galena Blvd.

Director Anastasia reported that work on the audit started today.

Chief Rollins reported that department members participated in CPR and safety recertification classes administered by the SG Fire Protection District. The Village collected 27lbs of prescription medication at the semi-annual Drug Take Back event held April 24. The lobby drop of medication box collected 140lbs of pills in the last six months.

President Konen thanks the police department for their work conducting traffic at the middle school.

Director Magdziarz reported that staff has met with develop Ryan Homes regarding building in the Settlers Ridge subdivision and he expects the topic to be before that board in June.
