
RE: Finance Report for May, 2014

The UAN report has been included in your packet. Some of the highlights from the General Fund have been summarized and described below:

General Fund Revenue

Earnings Tax

Earnings Tax collections for the month of May totaled \$191,054. This is up 2.4% from May 2013's collection of \$186,658 and up 4.3% compared to year-to-date in 2013. Earnings tax continues to be the Village's primary revenue source. This chart shows how the earnings tax has tracked since 2006. The estimate for 2014 is \$2,500,000.



Property Tax

The Village collected \$74,169 of rollback/homestead taxes during May.

Local Government Fund

The Local Government Fund has netted \$4,977 for May. The graph highlights the LGF Revenue for the years 2006- May 2014. The projection for 2014 is \$52,605.


