
RE: Finance Report for June, 2014

The UAN report has been included in your packet. Some of the highlights from the General Fund have been summarized and described below:

General Fund Revenue

Earnings Tax

Earnings Tax collections for the month of June totaled \$172,721. This is up 36% from June 2013's collection of \$127,780 and up 6.8% compared to year-to-date in 2013. Earnings tax continues to be the Village's primary revenue source. This chart shows how the earnings tax has tracked since 2006. The estimate for 2014 is \$2,500,000.



Property Tax

The Village did not receive property tax payments during June.

Local Government Fund

The Local Government Fund has netted \$5,180 for June. The graph highlights the LGF Revenue for the years 2006- June 2014. The projection for 2014 is \$52,605.


