## ORDINANCE NO. 2009-15

## ORDINANCE AMENDING SECTIONS OF THE AMBERLEY VILLAGE CODE OF ORDINANCES

**WHEREAS**, Council having determined the necessity of amending ordinances regarding parking on Village property and the use of tennis courts;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF AMBERLEY VILLAGE, OHIO, seven (7) members elected thereto concurring:

**SECTION 1**: That Section 75.27 be and hereby is, amended by adding the following language, which becomes Section 75.27(A)(8):

On any Village owned property.

**SECTION 2**: That Section 75.27(B) be re-lettered as subsection 75.27(C), and that the following language be and hereby is added as the amendment which becomes Section 75.27(B):

Prohibitions contained in this section shall not apply to authorized maintenance, public safety, or public utility vehicles.

**SECTION 3**: That Section 76.05(B) be re-lettered as subsection 76.05(C), and that the following language be and hereby is added as the amendment which becomes Section 76.05(B):

(B) No person shall stand, or park a vehicle, on Village property where a permit is required as posted unless said vehicle displays an Amberley Village Vehicle Identification Sticker or other designated parking permit authorized by Village Council.

**SECTION 4**: That Section 98.05(A) be and hereby is, amended by adding the following language, noted in bold:

(A) Use of the village tennis courts shall be restricted to residents of Amberley Village holding **current** key cards issued by the village, and their guests, **except as hereinafter provided.** 

**SECTION 5**: That Section 98.05 be and hereby is, amended by adding the following language, which becomes Section 98.05(C) :

(C) Use of village tennis courts may be extended to nonresidents as authorized by Village Council.

**SECTION 6**: That Section 98.09(A) be and hereby is, amended by adding the following language, to the beginning of the current section, noted in bold:

## (A) Except as authorized by Council, .

**SECTION 7**: This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety, and it shall go into effect forthwith. The reason for such emergency is to immediately provide rules and regulations, and safety measures, on village owned property.
