RESOLUTION NO. 2014-09

RESOLUTION AUTHORIZING THE VILLAGE MANAGER TO ENTER  
INTO CONTRACTS FOR MOWING SERVICES

WHEREAS, While the Village has cut back areas of its maintenance program in order to save money, the Village still requires essential lawn mowing and landscaping services at Amberley Green and several other areas of the Village, including the Village Hall property, Village-owned rights-of-way, and the North Site;

WHEREAS, Proposals from contractors were solicited for mowing services, and proposals were considered by the Streets, Public Utilities & Sewers Committee;

WHEREAS, As recommended by said Committee, based on the number of service calls, or “cuts,” in 2013, the lowest and best proposal was submitted by Frederick’s Landscaping for areas including the Village Municipal Building, Village rights of way, and the North Site, for a total quote of \$28,249.00;

WHEREAS, As recommended by said Committee, based on the number of service calls, or “cuts,” in 2013, the lowest and best proposal was submitted by EMES Lawn Care for areas including Amberley Green, for a total quote of \$15,840;

WHEREAS, Council determines it is in the best interest of the Village and its residents to approve separate contracts with the aforementioned companies for mowing services in 2014;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF AMBERLEY VILLAGE, STATE OF OHIO, seven (7) members elected thereto concurring,

SECTION 1: That the Village Manager is authorized and directed to enter into a contract on behalf of the Village with Frederick’s Landscaping for mowing services in 2014 based on the proposal submitted by that company for a total estimated cost of \$28,249.00, said contract to cover the Village Municipal Building, rights of way, the North Site, and any other areas contemplated by said proposal. Further, the Village Manager is authorized and directed to enter into a separate contract on behalf of the Village with EMES Lawn Care for mowing services in 2014 based on the proposal submitted by that company for a total estimated cost of \$15,840.00, said contract to cover mowing for the Amberley Green property. The execution and approval of both contracts is conditioned on approval by the Solicitor.

SECTION 2: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
