RESOLUTION NO. 2014-10

RESOLUTION AUTHORIZING THE VILLAGE MANAGER TO ENTER INTO A CONTRACT TO PURCHASE DUMP TRUCK

WHEREAS, the Maintenance Department performs a significant amount of valuable and necessary work for Village residents through the use of dump trucks and snow fighting equipment;

WHEREAS, from time to time the Village must purchase new equipment to replace that which has become outdated, inefficient, or unusable;

WHEREAS, the Maintenance Department determined, and Council finds, that the existing 2002 International dump truck has reached the end of its useful life and it has since become unreliable and costly to maintain;

WHEREAS, the Village has the opportunity to purchase a new dump truck (a 4700 International single axle dump truck) and snow plow attachments through the State of Ohio Purchasing Contract, which will yield good value for the new equipment at a price lower than the Village could achieve in the open market;

WHEREAS, Council previously budgeted an amount sufficient to cover the cost of the new equipment;

NOW, THEREFORE, BE IT RESOLVED BY THE Council of Amberley Village, State of Ohio, seven (7) members elected thereto concurring:

SECTION 1: That the Village Manager be, and hereby is, authorized and directed to enter into a contract on behalf of the Village with Rush Truck Center for the purchase of a new International 4700 Series Dump Truck (cab and chassis) for a price not to exceed \$80,397, and for a new dump body and snow fighting equipment with Kaffenbarger Equipment for a price not to exceed \$44,200, for a subtotal of \$124,597. The Manager is authorized to trade-in the 2002 truck in order to obtain a reasonable value, which is estimated by the company to be between \$8,000 and \$9,000. Over and above the purchase price, the Village Manager is authorized to pay any reasonable administrative fees charged as a condition of participating in the State of Ohio Purchasing Contract.

SECTION 2: This purchase is being made through the State of Ohio Purchasing Contract. The Clerk is hereby directed to file with the State a certified copy of this resolution. This resolution shall be considered by the State as a request for the Village to participate in the State of Ohio Purchasing Contract under ORC 125.04 and 5513.01. The Village agrees to be bound by such terms and conditions as the State prescribes and that the Village will directly pay the vendor under the purchase contract.
