RESOLUTION NO. 2016-6

**RESOLUTION AUTHORIZING THE VILLAGE MANAGER  
TO PURCHASE TWO PICKUP TRUCKS FROM BOB ROSS AUTO GROUP**

**WHEREAS**, the Maintenance Department performs a significant amount of valuable and necessary work for Village residents through the use of pickup trucks and snow fighting equipment;

**WHEREAS**, from time to time the Village must purchase new equipment to replace that which has become outdated, inefficient, or unusable;

**WHEREAS**, the Maintenance Department determined, and Council finds, that two existing vehicles have reached the end of their useful lives and they have become unreliable and costly to maintain;

**WHEREAS**, the Village has the opportunity to purchase two new pickup trucks through the State of Ohio Purchasing Contract, specifically two 2016 GMC 3500 Crew Cab single axle pickup trucks, from Bob Ross Auto Group for the base price of \$41,593 for each vehicle, which Council finds is necessary and reasonable;

**WHEREAS**, the vendor quoted a trade-in value on two older Village vehicles of \$7,600 and \$16,600, respectively, for a 2001 Dodge Ram and a 2006 Ford F250;

**WHEREAS**, Council previously budgeted an amount sufficient to cover the cost of the new equipment;

**NOW, THEREFORE, BE IT RESOLVED BY THE** Council of Amberley Village, State of Ohio, seven (7) members elected thereto concurring:

**SECTION 1:** That the Village Manager be, and hereby is, authorized and directed to enter into a contract on behalf of the Village with Bob Ross Auto Group for the purchase of two new 2016 GMC 3500 Crew Cab single axle pick-up trucks, for the base price of \$41,593 each, less any amount received as a credit to the Village on a trade-in, resulting in a total authorized contract price of \$33,993 for one vehicle and \$24,993 for the second vehicle. Over and above those amounts, the Village Manager is authorized to pay any reasonable administrative fees charged as a condition of participating in the State of Ohio Purchasing Contract.

**SECTION 2:** This purchase is being made through the State of Ohio Purchasing Contract. The Clerk is hereby directed to file with the State a certified copy of this resolution. This resolution shall be considered by the State as a request for the Village to participate in the State of Ohio Purchasing Contract under ORC 125.04 and 5513.01. The Village agrees to be bound by such terms and conditions as the State prescribes and that the Village will directly pay the vendor under the purchase contract.

**SECTION 3:** This Resolution shall take effect and be in force from and after the earliest period allowed by law.
