

RESOLUTION NO. 2009-R-9A

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ANGLETON, TEXAS, ANNOUNCING THAT IT WILL VOTE ON A TAX RATE THAT WILL RESULT IN A TAX REVENUE INCREASE AT ITS MEETING ON SEPTEMBER 22, 2009; PROVIDING FOR PUBLICATION OF A NOTICE OF TAX REVENUE INCREASE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, at its meetings of August 11, 2009, the City Council of the City of Angleton, Texas (City) unanimously voted to place a proposal on the September 22, 2009 City Council agenda to adopt a proposed tax rate of \$0.706000 per \$100 valuation, which will exceed the lower of the rollback rate or the effective tax rate; and

WHEREAS, the City Secretary duly recorded the vote of the City Council on that matter; and

WHEREAS, the City Council also called two public hearings on the tax increase, the first for its meeting of August 25, 2009 and the second on September 8, 2009; and

WHEREAS, publication and posting of notice of two public hearings on the tax increase were made in accordance with the law, and a hearing was held on August 25, 2009 and September 8, 2009, and all proponents and opponents of the tax increase were given an adequate opportunity to present their views at the public hearings; and

WHEREAS, at the public hearings, the City Council announced the date, time and place of the meeting at which it will vote on the proposed tax rate; and

WHEREAS, the City Council wishes to finally set the date, time and place of the meeting at which it will vote on the tax rate;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ANGLETON, TEXAS:

SECTION 1. The findings set forth in the preamble of this Resolution are incorporated by reference into the body of this Resolution as if fully set forth herein.

SECTION 2. The City Council will vote on the proposed tax rate of \$0.706000 for each \$100 of taxable value that will result in a tax revenue increase at its meeting of September 22, 2009, which will commence at 6:00 p.m. and will be held in the City Council Chambers at City Hall at 120 S. Chenango, Angleton, Texas 77515.

SECTION 3. Prior to the vote on the proposed tax rate, the Brazoria County Tax Assessor/Collector or her designee, in accordance with the City's contract with Brazoria County, is directed to publish in The Facts, a newspaper having general circulation in the City, a Notice of Tax Revenue Increase. Such publication to be in compliance with the requirements of the Texas Property Tax Code (Tax Code) and other applicable laws. The City Manager, or his designee, is directed to post the attached Notice of Tax Revenue Increase on the City's Internet website (and shall request that the City's public access television channel carry a 60-second Notice of Tax Revenue Increase) at the times and for the periods and in accordance with the requirements of the Tax Code and other applicable law.

SECTION 4. This Resolution shall become effective immediately upon its passage and approval at the meeting of the City Council of the City of Angleton, Texas on this the 22nd day of September, 2009, at which meeting a quorum was present and the meeting was held in accordance with the provisions of Tex. Gov't Code §551.001, *et seq.* The City Secretary is hereby advised to record this Resolution and the vote on the proposal to place the item for a vote on the tax rate that will result in a tax increase on the September 22, 2009 City Council agenda.
