

RESOLUTION NO. 2009-R-9B

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ANGLETON, TEXAS, ANNOUNCING THAT IT WILL VOTE ON THE 2009-2010 FISCAL BUDGET OF THE CITY OF ANGLETON, TEXAS (BUDGET) AT THE MEETING OF SEPTEMBER 22, 2009; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, at its meeting of August 11, 2009, the City Council called public hearings on the 2009-2010 Fiscal Budget of the City of Angleton, Texas (Budget) for the City of Angleton, for its meetings of August 25 and September 8, 2009; and

WHEREAS, publications of notice of the public hearings on the Budget were made in accordance with the law, the hearings were held on August 25, 2009 and September 8, 2009, and all proponents and opponents of the Budget were given an adequate opportunity to present their views at the public hearing; and

WHEREAS, the City Council wishes to finally set the date, time and place of the meeting at which it will vote on the adoption of the Budget;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ANGLETON, TEXAS:

SECTION 1. The findings set forth in the preamble of this Resolution are incorporated by reference into the body of this Resolution as if fully set forth herein.

SECTION 2. The City Council will vote on the adoption of the 2009-2010 Fiscal Budget of the City of Angleton, Texas (Budget) at its meeting of September 22, 2009, which will commence at 6:00 p.m. and will be held in the City Council Chambers at 120 S. Chenango, Angleton, Texas 77515.

SECTION 3. The City Council ratifies and approves the form of the Notice of Public Hearing on Budget as published in The Facts newspaper on August 14 and August 20, 2009 and the actions of the City Manager, or his designee, in publishing same.

SECTION 4. This Resolution shall become effective immediately upon its passage and approval at the meeting of the City Council of the City of Angleton, Texas on the 22nd day of September, 2009, at which meeting a quorum was present and the meeting was held in accordance with the provisions of Tex. Gov't Code §551.001, *et seq.* The City Secretary is hereby directed to record this Resolution and the vote on the proposal to place the item for adoption of the Budget on the September 22, 2009 City Council agenda.
