PRESIDENT MOURY: Okay. I'd like to call to order the Regular Council Meeting of February 8, 2021.

Mr. Christian, would you please call the roll.

MR. CHRISTIAN: Dr. Campbell?

DR. CAMPBELL: Present.

MR. CHRISTIAN: Mr. Cenci?

MR. CENCI: Here.

MR. CHRISTIAN: Mr. Consolmagno?

MR. CONSOLMAGNO: Here.

MR. CHRISTIAN: Ms. Gibbons?

MS. GIBBONS: Here.

MR. CHRISTIAN: Mr. Hannan?

MR. HANNAN: Present.

MR. CHRISTIAN: Mr. Harrison?

MR. HARRISON: Present.

MR. CHRISTIAN: Mr. McLean?

MR. McLEAN: Here.

MR. CHRISTIAN: Mr. Moury?

PRESIDENT MOURY: Here.

MR. CHRISTIAN: Mr. O'Brien?

MR. O'BRIEN: Present.

1 PRESIDENT MOURY: We have all nine
2 members present.

3 For those here, could we stand for
4 the Pledge of Allegiance.

5 (Whereupon, the Pledge of Allegiance
6 was recited.)

7 PRESIDENT MOURY: Okay. At this
8 time, I would like to turn to Chair
9 Announcements, February 8, 2021. Before we
10 came to the floor, we had an executive session
11 for legal and personnel issues.

12 At this time, I would like to turn to
13 the Reports of the Officials, and the Police
14 Chief's Report; and Chief O'Connor.

15 CHIEF O'CONNOR: Mr. Mayor, Council.
16 Council -- oh, there you are.

17 Good evening, Chief here. I just
18 want to report that Bethel Park Police
19 Department, we're fully functioning throughout
20 the current COVID crisis. There's no better
21 evidence of this as we keep the ACJ, the
22 Allegheny County Jail, stocked with fresh
23 souls on a weekly basis, and we will continue
24 to do so.

25 So you follow us online. We will

1 have important updates for the community. And
2 you can always reach us via email or give us a
3 call in the office. And we hope to see you
4 all in person hopefully soon this year. Thank
5 you.

6 Questions?

7 PRESIDENT MOURY: Thank you, Chief
8 O'Connor.

9 Any questions?

10 (No response.)

11 PRESIDENT MOURY: Hearing none; can
12 we turn to the Library Director's Report.

13 MS. McINTOSH: Good evening. My
14 name's Christine. I'm the Director of your
15 Public Library, where we provide opportunities
16 to explore, learn, create, and connect.

17 The Library is open our regular
18 operating hours, which is Monday through
19 Thursday, 10:00 a.m. until 8:00 p.m.; Friday
20 and Saturday, 10:00 a.m. until 5:00 p.m.; and
21 Sundays, 1:00 p.m. until 5:00 p.m.

22 While we're open for in-person
23 services, you can come in and browse, use the
24 computer, use the copier. Most of our
25 programs are still virtual. All of our

1 programs for youth are virtual. But there's a
2 few I'd like to tell you about.

3 On Wednesday, February 10, at 4:00
4 p.m., we have Book Bites for grades three and
5 four. We'll start a new book together by
6 Zoom. And if you like what you hear, come on
7 into the Library and check out that title.

8 On Saturday, February 13, at
9 11:00 a.m., we have Mad About You for grades
10 two through four. Join us via Zoom to
11 collaborate to create a Valentine's Day's
12 themed mad libs, where you will add nouns and
13 verbs and adjectives to create a funny story.

14 Tuesday, February 16, at 10:00 a.m.,
15 we have virtual show-and-tell for three- to
16 six-year-olds with a caregiver. This is an
17 opportunity for your child to practice
18 talking, listening, and taking turns.

19 All those programs, you do have to
20 register for ahead of time so we can send you
21 a Zoom link.

22 And then we have few in-person
23 classes for adults coming up. On Friday,
24 February 12 at 10:30 a.m., we have "Appy Hour"
25 for older adults, where you'll learn what's

1 new in the world of apps.

2 This is geared toward those that are
3 50 and older. We ask that you bring your
4 phone or a tablet. And this is limited to ten
5 people so that we can safely socially
6 distance, so we do ask that you register.

7 We're starting to host an open mic
8 event. Our next one will be Saturday,
9 February 20, at noon. So whether it's a cover
10 song, an original song, a poem, a short story,
11 we are welcoming all forms of creative
12 writing.

13 So you can come and -- you need to
14 sign up, just so we know. We don't want too
15 many people coming at once.

16 And -- oh, it's tax season. The
17 Library does have a limited number of federal
18 and state tax forms available. We are not
19 offering the AARP tax assistance this year.
20 But we do have a list of locations in the
21 area. So if you need some assistance finding
22 a location, just give the Library a call.

23 And, also, on the Library's website,
24 we do have information on the COVID-19
25 vaccination, guidelines and questionnaire to

1 see if you're eligible yet, and a provider
2 list. So check out our website at
3 Bethelparklibrary.org.

4 That is all I have.

5 PRESIDENT MOURY: Thank you very
6 much.

7 MS. McINTOSH: Thank you.

8 PRESIDENT MOURY: Are there any
9 questions?

10 (No response.)

11 THE REPORTER: Mr. Moury, could you
12 move up, please to the microphone.

13 PRESIDENT MOURY: Is that any better?

14 THE REPORTER: Yes.

15 PRESIDENT MOURY: Thank you.

16 At this time, can we turn the Fire
17 Chief's Report.

18 (No response.)

19 PRESIDENT MOURY: We don't have
20 anybody from the Fire Department on.

21 Could we turn to the Mayor's Report;
22 and Mayor Allen.

23 MAYOR ALLEN: Okay. Thank you,
24 Mr. Moury.

25 I have a few items tonight. I wanted

1 to talk about the COVID-19 vaccination
2 program. If you are a veteran, you can go to
3 the VA Hospital -- or, actually, any
4 VA Hospital. You have to be affiliated with
5 them, but they can sign you up. So if you're
6 a veteran, you can do that almost immediately.

7 You can also go to our website
8 Bethelpark.net, and that will give the
9 locations that are near us with -- a pretty
10 fair proximity as far as where you can get --
11 or sign up to get your vaccination. You can
12 also go to vaccinatepa.org, and that will give
13 you a bigger list of places you can go to sign
14 up.

15 And as you probably know, Bethel Park
16 partnered with Spartan Pharmacy for a COVID
17 clinic on January 27. And I wanted to
18 personally thank Laurence and his team of
19 volunteers. It was a great success. We're
20 currently looking to do another one in the
21 near future.

22 But keep in mind, the Municipality
23 has nothing to do with scheduling the
24 appointments. That particular one would have
25 to have been scheduled at the pharmacy,

1 Spartan Pharmacy.

2 So far this year, we've had a rough
3 winter. And I want to thank Public Works for
4 doing an outstanding job. We've heard nothing
5 but praise for the job that they did to keep
6 the roads clean for our residents.

7 But a couple things you can do: You
8 can keep your cars parked in your driveway,
9 off the road so the plows can get through.
10 And, also, if you can clean around the mailbox
11 so the mail carrier can deliver your mail. If
12 there's too much snow there, they'll just pass
13 it up.

14 And, also, if it happens to snow on
15 the day that you have trash pickup, please
16 bring the cans back, because the trucks will
17 not stop. And we really don't want your trash
18 cans spread all along in your neighborhood.

19 And, finally, we're asking our
20 residents and businesses to show some love
21 this Valentine's Day with the Bethel Park
22 Kindness Projects, Wear Your Heart On Your
23 Window.

24 That's an event that will run through
25 Sunday, February 14th. To participate, simply

1 decorate the front window or door of your home
2 or business with a heart, a message of
3 kindness, or both. And then once done, take a
4 picture of your completed work and share it in
5 the Comment Section under our special
6 Valentine's Day post found on our Municipal
7 website -- or I'm sorry -- our Facebook page.

8 If you need help getting started,
9 head over to Evey True Valve Hardware at 5779
10 Library Road for a free red, washable Crayola
11 marker. And supplies are limiting -- limited,
12 so head over there soon. Good luck. It's
13 just another kindness thing for our residents
14 here in Bethel Park.

15 And that's all I have. Thank you.

16 PRESIDENT MOURY: Thank you very
17 much, Mayor Allen.

18 At this time, can we turn to the
19 Municipal Manager's Report; and Mr. Christian.

20 MR. CHRISTIAN: Thank you, President
21 Moury, members of Council. Thank you so much,
22 Mayor Allen. Chief O'Connor, thank you.

23 Normally I like to welcome new staff
24 in person. But as the Coronavirus has shown,
25 we cannot do that one. So I would like to

1 welcome a couple of members that are new to
2 the staff.

3 First and foremost, I would like to
4 welcome our new Finance Director, Lisa
5 Lapaglia, who joined our team in the fall, and
6 has immediately made an incredible impact on
7 the Municipality. From budget development to
8 process improvement, Lisa is making incredible
9 strides, and credits her team, which consists
10 of Pam Inglis, Janet Davin, Haya Eason, and
11 Susann Beardsley, with all of her success.

12 One of our new directors, Director of
13 Special Projects, Drew Dowdell, is credited
14 with upgrading our entire IT infrastructure
15 and ubiquitously bringing us to the cloud,
16 where we haven't been yet. This has been a
17 huge, huge process improvement, and we're very
18 excited where we're going right now.

19 And the last person to bring on to
20 the team right now is our Assistant to the
21 Manager, Adam Steele. Adam moved to the
22 Greater Pittsburgh area after completion of
23 his Masters in public administration and an
24 18-month-long internship with the town of
25 Colleyville, Texas. He has jumped right into

1 the fold and is lending a hand wherever and
2 however he can.

3 I would like to just take a couple
4 minutes real quick and kind of give you a
5 brief rundown of the state of the
6 Municipality.

7 As we are quickly approaching the
8 one-year mark for this worldwide pandemic, and
9 from my perspective, there truly is hope on
10 the horizon. There are multiple vaccines in
11 mass production, and they will be continued to
12 be distributed to health organizations and
13 pharmacies for vaccination clinics.

14 While the Municipality of Bethel Park
15 does not receive or control any of these
16 vaccines, we will continue to partner with --
17 to facilitate large-scale vaccination clinics
18 as much as possible.

19 We partnered with Spartan Pharmacy,
20 as the Mayor mentioned, and they were able to
21 vaccinate over 2,000 residents. That is
22 amazing. And we will continue to help in any
23 way we can.

24 And following up with the Mayor, I
25 would like to highlight a couple of our

1 departments, starting with the Public --
2 Department of Public Works. And if it's
3 snowing, you can bet that there are at least
4 13 drivers out there clearing the 130 miles of
5 roads across Bethel Park.

6 What you don't know is some of the
7 vast array of our -- of the duties the Public
8 Works employees handle, ranging from the
9 maintenance of our 12 parks, three green
10 spaces and common areas, to rebuilding
11 hundreds of storm sewer inlets, and patching
12 potholes throughout the entire year -- 12
13 months a year they do this -- doing minor
14 repairs for our storm and sanitary sewer
15 system, and so much more. They are a small
16 team, but they have a big impact on Bethel
17 Park.

18 Please -- my apologies. It helps our
19 friends and neighbors, if you please remember,
20 to please park in your driveway, just like the
21 Mayor said, shovel your driveways, and keep
22 your cans where that -- back into your house
23 area.

24 And also remember, when there is snow
25 on the horizon, please park in your driveways,

1 because it takes about three hours for our
2 crews to do one run. That's a long time to be
3 away from your street.

4 Another department that is our --
5 what I considered is our unsung heroes, the
6 Wastewater Treatment Plant. You never hear
7 about them, yet they go about their daily
8 duties. And if they didn't, you sure would
9 know about it really fast.

10 Their professionalism and dedication
11 is amazing. And while the profession of
12 treating wastewater has always been a hands-on
13 profession, COVID has brought on new issues
14 about discarding cleaning wipes into the
15 sanitary sewer system.

16 If we could ask for one favor of our
17 residents, that would be, please, do not flush
18 any cleaning or sanitary wipes down the
19 sanitary sewer system. It is causing massive
20 clogs and sewer backups in the treatment
21 plant. It may say they are flushable, but
22 they are not. Trust us.

23 Our dedicated professionals had to
24 tear apart raw sewage pumps on a weekly basis.
25 That sounds just as ugly and disgusting as it

1 actually is in person. Please do not flush
2 these wipes. For more information, please go
3 the website www.bethelpark.net for a nice
4 public service announcement on what to flush.

5 A couple small departments;
6 Engineering, Planning, Code Enforcement, they
7 have been doing yeoman's work over the last 12
8 months, and they continue to do it on a daily
9 basis. Everything from handling the road
10 program, storm sewer inlets, manhole
11 maintenance, major storm and sanitary repairs.
12 I can go on and on. But this small group of
13 quiet professionals do it day in and day out.

14 Our Rec Department, just a handful of
15 employees are slowly bringing about a whole
16 new program of at least 20 right now, and more
17 getting started every month. They are safe.
18 They are enlightening for all of our -- from
19 youth all the way up to our senior
20 programming. And we want to say our Community
21 Center is one of the best in the area. And we
22 want you to come visit us.

23 Moving on to the -- to the last
24 department I want to highlight tonight, the
25 Bethel Park Police Department. Starting with

1 our very own Chief of Police and moving across
2 the entire department, these quiet
3 professionals fully epitomize the old adage,
4 "The few protect the many." 24/7, 365, you
5 can count on our streets to be safe because of
6 our dedicated professionals.

7 And one last public service
8 announcement, please visit our website as we
9 continue to promote the Local Business
10 Initiative and our Shop Local campaign.

11 I would like to stand here for the
12 next hour and recite every employee, but there
13 just isn't enough time. There are so many
14 dedicated municipal employees. I wish I had
15 time to list them all, but I don't. But I'll
16 simply say, it is an honor to serve with each
17 and every one of you. Thank you so much.

18 PRESIDENT MOURY: Thank you,
19 Mr. Christian.

20 Are there any comments?

21 (No response.)

22 PRESIDENT MOURY: Hearing none, can
23 we turn to the Approval of the Minutes; and

25 MR. HANNAN: Approval of Minutes for

20 PRESIDENT MOURY: Mr. Christian,
21 would you please call the roll.

22 MR. CHRISTIAN: Dr. Campbell?

16 At this time, I'd like to turn to the
17 Residents' Comment Section.

18 I apologize for the people here this
19 evening, we normally have copies of the
20 agenda. And, unfortunately, we don't have any
21 out this evening. But we will next time.

22 Right?

23 MR. CHRISTIAN: Yes, sir.

24 PRESIDENT MOURY: Thank you.

25 Are there any resident comments on

1 agenda or non-agenda items?

2 If you'd like to come up to the
3 microphone and state your name and address
4 from the -- for the record. We have a
5 three-minute limit. And then we can --

6 MS. BROWN: Okay. Do I face this way
7 or this way?

8 PRESIDENT MOURY: Whatever you feel
9 comfortable. If you want to see the TV, look
10 that way (indicating). If you want to us --

11 MS. BROWN: Oh, no, I don't want to
12 see the TV or myself on it.

13 Okay. My name is Jacquelin Brown. I
14 live at 1001 Fairview Drive. And I wanted to
15 inquire about the feasibility of having a
16 sidewalk along Logan Road that goes to the T
17 stop.

18 I travel downtown on the T to
19 Pittsburgh. And so right now, I'm having to
20 walk along the road, which presents safety
21 concerns, particularly in the winter, in
22 evening, when it's dark outside.

23 So I don't know what type of action
24 you guys do on things, if you discuss things,
25 or what. But I just wanted to present it.

1 MR. O'BRIEN: Mr. Moury?

2 PRESIDENT MOURY: Mr. O'Brien.

3 MR. O'BRIEN: Unfortunately, that is
4 a state road, Logan Road.

5 MS. BROWN: Okay.

6 MR. O'BRIEN: You'd have to get --
7 it's difficult. We always looked at doing it.
8 But it is a difficult procedure with working
9 with the state and the width of the road.

10 So that's something we were thinking
11 about for a long period of time. It's in our
12 thought process, along with the Montour Trail,
13 which is up -- up the way.

14 MS. BROWN: Oh, you mean a sidewalk
15 to get from -- along Logan Road to the trail?

16 MR. O'BRIEN: Yes.

17 MS. BROWN: Right. That would be
18 great, too.

19 MR. O'BRIEN: Yeah.

20 MS. BROWN: Okay.

21 PRESIDENT MOURY: One of the things
22 we're also working on developing from our
23 Planning Commission is a long-term strategy
24 for mobility and sidewalks.

25 So if you wanted to leave your name

1 and information. Actually, you can leave it
2 on the back of this, and then we'll let you
3 know when, like, the Planning Commission is
4 going to be meeting to talk about it.

5 They're also working on, for Bethel
6 Park roads, an Ordinance on how to approach
7 the neighbors in the neighborhood about
8 getting a sidewalk done. And they'll be
9 working on that over the next several months.

10 MS. BROWN: Okay. Sounds good.

11 PRESIDENT MOURY: If you can leave
12 your name and email and phone number, we can
13 -- we'll be in touch with you when we get to
14 that point. We'll let you know when the
15 meetings are going to be.

16 MS. BROWN: Okay. Should I come up
17 there and grab that?

18 PRESIDENT MOURY: Yes.

19 MS. BROWN: Okay. Thank you.

20 PRESIDENT MOURY: Okay. Is any other
21 residents who would like to speak?

22 (No response.)

23 PRESIDENT MOURY: Hearing none, can
24 we turn to General Policy and Finance, and
25 he's got about 25 items on our agenda; and

1 I'll turn to Mr. McLean.

2 MR. McLEAN: Thank you, Mr. Moury.

3 The first item under General Policy
4 and Finance is the 2021 Capital Computer
5 Workstation and Peripheral Equipment
6 Replacement.

7 I move that we approve the purchase
8 of 21 laptops, 42 monitors, 21 docking
9 stations, and 21 wireless keyboard and mice
10 combos from DelleMC in the amount of
11 \$37,584.55 per the IT Administer's memorandum
12 dated January 18, 2021.

13 MS.GIBBONS: Second.

14 PRESIDENT MOURY: There's a motion by
15 Mr. McLean and second by Ms. Gibbons that we
16 approve the purchase of 21 laptops, 42
17 monitors, 21 docking stations, and 21 wireless
18 keyboard and mice combos from DelleMC in the
19 amount of \$37,584.55 per the IT Administer's
20 memorandum dated January 18, 2021.

21 I'll briefly comment on this. Over
22 the last few months, we've spent a lot of
23 money on the IT infrastructure. We're
24 switching everybody over to the Office 365,
25 which the conversion happened over this past

1 weekend.

2 And this is kind of the second or
3 third step of the process. We never really
4 had a strategy on updating the computers
5 within the Municipality. We're now
6 implementing a strategy to upgrade all our
7 facilities, particularly the IT structure.

8 Any other discussion from Council?

9 (No response.)

10 PRESIDENT MOURY: Mr. Christian,
11 would you please call the roll.

6 PRESIDENT MOURY: Motion passes 9-0.

7 Mr. McLean.

8 MR. McLEAN: The next item under
9 General Policy and Finance agenda is Ordinance
10 No. 2-8-21, Referendum to Amend the Home Rule
11 Charter.

12 I move that we approve Ordinance
13 2-8-21 to initiate a referendum to amend the
14 Home Rule Charter to remove provisions
15 requiring the Municipal Planner to become a
16 resident of the Municipality of Bethel Park
17 within one year of employment.

18 MS.GIBBONS: Second.

19 PRESIDENT MOURY: There's a motion by
20 Mr. McLean and second by Ms. Gibbons that we
21 approve Ordinance 2-8-21 to initiate a
22 referendum to amend the Home Rule Charter to
23 remove the provision requiring the Municipal
24 Planner to become a resident of Bethel -- the
25 Municipality of Bethel Park within one year of

1 employment.

2 I'll briefly comment. This is a
3 question we're looking to put on the main
4 ballot. And it really asks the public. In
5 our Home Rule Charter, we currently have four
6 positions within the Municipality: The
7 Manager, the Police Chief, the Financial
8 Director, and the Planer must become a
9 resident of Bethel Park within one year.

10 What we're experiencing is, while we
11 have to get the best people that have the most
12 experience, because this is somewhat of a
13 specialized position, that we're going to open
14 it up to somebody that lives outside of the
15 community. We always try to hire people
16 within that are currently Bethel Park
17 residents. But in a position that's
18 specialized, we don't always have this
19 opportunity.

20 So we'll be talking about this for
21 the next few months. But this is a referendum
22 that will be placed on the ballot for the
23 residents of Bethel Park to vote on.

25 people to jump from Capitalism to Communism,

1 but we can assist their elected leaders in
2 giving them small doses of Socialism, until
3 they awaken one day until to find that they
4 have Communism. We do not have to invade the
5 United States, we will destroy you from
6 within."

7 And that's the end of the quote.
8 This is a quote by then-Soviet Premiere Nikita
9 Khrushchev a few decades ago.

10 I claim as of January 20, 2021, the
11 USA has become a socialist nation. Americans
12 need to acknowledge this fact and immediately
13 expend the effort required to reverse it.

14 Now, on -- on this letter, there's
15 suggestions of what we as citizens can do to
16 recover from this disaster. And I'll just
17 tell the people, if you would like to make

11 Director's memorandum dated February 5, 2021.

12 I hope, Mr. Christian, you're going
13 to stop spending all this money one of these
14 days.

15 Any discussion from Council?

16 (No response.)

17 PRESIDENT MOURY: Hearing none,
18 Mr. Christian, would you please call the roll.

19 MR. CHRISTIAN: Dr. Campbell?

20 MR. CAMPBELL: Yes.

21 MR. CHRISTIAN: Mr. Cenci?

22 MR. CENCI: Yes.

23 MR. CHRISTIAN: Mr. Consolmagno?

24 MR. CONSOLMAGNO: Yes.

19 time -- the 19 times, they've distributed
20 7,000 tons of salt, 4,000 gallons of brine,
21 and 4,600 gallons of calcium. The cost of the
22 salt is close to \$500,000.

23 But isn't it nice when you're
24 sleeping in bed that you hear the salt truck
25 go by your door? Well, these poor guys and

1 gals, you know, 19 times between December and
2 January, it's been a brutal winter so far for
3 them.

4 But I just wanted to say hats off to
5 all the Public Works, and Susan Doyle --
6 Dolinar for doing, you know, such a great job
7 on our streets and that stuff.

8 Sometimes the weather doesn't
9 cooperate as much. You know, they're out, and
10 then, you know, they're -- they get a break,
11 and then before you know it, they're back out
12 again because Old Man Winter decided to dump a
13 little bit more snow on the streets. So, you
14 know, just thank you for doing a fine job.
15 That's all.

16 PRESIDENT MOURY: Thank you,
17 Mr. Consolmagno.

18 Are there any additional comments?

19 PRESIDENT MOURY: Hearing none, can I
20 have a motion to adjourn?

21 MR. HANNAN: I move we adjourn.

22 PRESIDENT MOURY: A motion by Mr. --

23 MR. O'BRIEN: Second.

24 PRESIDENT MOURY: -- Hannan, second
25 by Mr. O'Brien.


