part-time position that would offer more

classes for adults and kids or over a thousand

books and e-books for you to enjoy.

This is a major success of the advocacy efforts of the library community.

It comes from years of having conversations and building relationships with our legislators.

We had major cuts in 2008. They cut 50 percent of the subsidy for the public libraries. And this success is key from Chairman Stan Saylor, who really worked hard and has been a library champion. He is the House Appropriations Chair, and he is from York County. He's worked on four budget cycles to help restore a loss of nearly 20 million dollars that we incurred in 2008 and 2009.

I'd also like to thank Senator

Devlin Robinson, Representative Natalie

Mihalek, and Representative Mike Puskaric for their approving the budget as well. I'm so excited about this. I just got this news today.

I'm here tonight to tell you a little bit about it. While I did receive a lot of support from our local businesses and organizations, I want to let you know more about the support that I received from the Municipality of Bethel Park itself, and to express my gratitude.

I have a very successful new and used book drive benefitting an organization called the Pittsburgh Prison Book Project. This great group sends books and reading material to incarcerated people all across Pennsylvania.

They rely on donations. And I focus my efforts on collecting the much-needed nonfiction books like do-it-yourself books, trade topics such as plumbing and wiring, crossword and puzzle books, and history subjects. I also collect cash donations to help cover the postage fees to send these books to their new readers.

My goal is to match each book with one dollar to account for the average postage cost that it takes to send in to the prison system.

During the month of May, the Bethel

Park Parks and Recreation Department welcomed

me and by Boy Scout volunteers at the Bethel

Park Farmer's Market. For each of the five

Tuesdays in May, I ran my own booth collecting

books and monetary donations from members of

our community.

The Bethel Park Library also helped me collect books by setting up a donation box that people could drop off at during their regular business hours throughout May.

My project wasn't a typical Eagle project, and it relied heavily on community involvement. I needed a convenient and consistent place for the public to be able to bring books me to. Our popular Farmer's Market and Library were perfect for this. I was able to have a clear message on where and when to bring the donations. And our neighbors sure did deliver.

Before I began, my original goal was

500 books. In total, and from my various efforts, I collected over 3,100 books. I collected 1,605 books from the Farmer's Market booth alone. I was also able to raise \$710.94 from my trusty penny jar over those five weeks. I also received 341 books from the donation box at our Library.

I absolutely could not have had such a successful outcome without the support from the Municipality of Bethel Park. I wanted to thank Mr. Laurence Christian for his generous permission for my Farmer's Market booth. And also to thank my Councilmen in Ward 6, Mark O'Brien, and my friend, Councilwoman Lindsay Flinn, for their early support and -- I'm sorry -- early support and encouragement.

Also, the new Farmer's Market coordinator, Lindsey Sibert, was really helpful and fun to work with. The Bethel Park Library Director, Ms. Christine McIntosh, was also very encouraging, understanding my project and goals from day one.

While I'm still writing my final report, I did want to come here with you and express my gratitude and share some of these

- numbers with you. I have now begun
 volunteering outside of my service project
 with the Pittsburgh Prison Book Project team,
 and I can tell you that so many of our
- 5 community books have already been sent to their new readers.
- I'm proud of my what team of

 volunteers have done and what I've

 accomplished. And I'm also proud to be a part

 of this Bethel Park community.

MR. TAGGART: Yes, my name is Darrell Taggert. I live on 255 Lisa Drive.

The issue I'd like to comment on this evening is the group home that Passavant

Memorial Homes is wanting to place on Lisa

Drive.

What we learned on -- in the recent Zoning Board meeting is that Passavant Memorial Homes is wanting Bethel Park to change their definitions and laws so they can operate their facility in an R-2 residential zone.

They purchased a \$440,000 home, knowing that they currently do not meet the R-2 zoning criteria. Did Passavant Memorial Homes have some reassurance that Bethel Park was not going to block the facility when they paid the exorbitant amount for the home?

If this variance gets approved, it will appear as though it was a done deal before the purchase. A zoning change such as this would be a prime example of spot zoning, the very anthesis of Bethel Park's planned zoning.

I feel our Council and local government are not enforcing the zoning laws the Municipality has in place. Just because there are other group homes in Bethel Park does not make it right to permit this assisted living facility in this tightly-populated

community.

This 24/7 staffed facility should be rightly placed in an R-4 or R-5 zone. Passavant's justification for this definition change is based on someone's opinion of what was written and how it was interpreted. Regardless of how many cases, these interpretations are not always correct. assessment should be evaluated on a case-by-case basis.

If the group home is allowed, any property owners in the neighborhood that would want to sell will see a significant loss in value. Is there a study of how this would affect surrounding property values? Or does the Council not care how it affects their constituents?

There will be an increase in traffic on all the streets that lead to or intersects Lisa Drive. We've had an influx of young families moving into our neighborhood. People leisurely walk and jog on the streets day and night, and many walk their dogs.

Was there a traffic study done to see how this group home and the services it

MS. HATFIELD: Karen Hatfield, 248 Lisa Drive, Bethel Park. I want to address the same issue, the group home at 242 Lisa Drive.

We received a copy of the request from Passavant. And they are citing a case in Clairton as the reasons for redefining the definition of family and arguing the zoning issue.

And the Clairton case was different because the Clairton zone had a nonprofit church in their community, and somebody wanted to buy it and convert it. And so they were deemed that it was discrimination based on the Fair Housing Act because they were actually -- they wanted to change the definition of their zoning to leave out a group home, when it was already zoned for nonprofit.

Now Passavant's coming in -- and I reaffirm what Darrell said. They came in knowingly knowing that it was an R-2 zone. They could have bought in an R-4, an R-5, a

1 C-1, -2, or -3, and probably bought two houses
2 for what they paid. They paid over -- at
3 least 50,000 over asking price to get this.

So the question is -- when we went to the Zoning Board meeting, they said, "We cannot rule on this. We cannot change the definition of family. It has to come before the Bethel Park board." You have to change the definition of family. Okay. The Zoning Board did not rule on it. We're still, you know, waiting.

The attorney did speak at the Zoning Board. He wasn't sworn in. That was a concern of ours. Because he said he was just speaking on behalf of his client, but he -- he was advising his client. But he did speak, and he wasn't sworn in.

And so my concern is, even though this is an R-2 and it's one particular house -- and I -- my -- I do struggle in my heart because these could be people with just Down Syndrome that just want to have a good life.

But if you change the zone definition of family to include people with disabilities,

```
multiple people in a home, this would apply to all Bethel Park, all R- -- you know, every R-2 zone. Then it will be R-1 zones. And then there's no limit. They can just buy up any -- you know, multiple, multiple houses.

So we're saying we're not discriminating. There is zone 4, 5, C-1, -2, and -3. And we're just asking you to consider when you're voting to vote against changing the definition of family.

MS. CARPER: Lisa Carper, 3315 Appel Road.

At last week's Zoning Board meeting,
Mr. Regan and the gentleman on behalf of
Passavant, there was a discussion of whether
or not someone would be staying at the home to
provide care in addition to the three
patients.

Passavant's representative answered,
"Yes, for two and a half days. Then another
person of care will come in for another two
and a half days."

When Regan asked, "Where will they be staying," Passavant answered, "In the basement."

2.3

I spoke with Allegheny County Health Department of Housing and Community Environment regarding 28 PA. Code 51.5. This code is found at the bottom of Bethel's Occupancy Permit form.

The inspector said one person staying there for two days counts as a fourth person. He said sleeping in the basement is not permitted since there are no egress windows, no exterior door, no basement in the -- no bathroom in the basement.

The variance application asks: "If granted, will this alter the essential character of the neighborhood?" Yes, this will alter the neighborhood in the negative way in more ways than one.

Our neighborhood is being spot zoned, and the character will most certainly be changed. The Commonwealth Court of Pennsylvania has even stated spot zoning is unconstitutional and that all zoning ordinances are presumed constitutional.

From an excerpt of the FHA 42 U.S.C. 3601, updated May 31, 2022, to refuse to make reasonable accommodations in land use and zoning policies and procedures where such accommodations may be necessary to afford persons or groups with disabilities and equal opportunity to use and enjoy housing.

2.3

What constitutes a reasonable accommodation is a case-by-case determination. Not all requested modifications of rules or policies are reasonable. If a requested modification imposes an undue financial or administrative burden on the local government or if modification creates a fundamental alteration in a local government's land use and zoning scheme and is not a reasonable accommodation.

It is very misleading to us as residents because only three people are permitted to move into the home, yet we have been told by numerous sources that five people or more will be living there, not three.

Seven years ago, we would not have had a case. The laws have changed. The excerpt FHA 42 U.S.C. 3601 update, spot zoning

this property and preserving neighborhood choice rule all favors to the neighbors in the R-2 zoning neighborhood. These are our fair housing rates. We are just looking for honest and support from our community and those who represent us.

In conclusion, thank you for saying the Pledge of Allegiance. It honors the flag, as well as the representative's rule in serving the American people. All laws must comply with the Constitution or they are void.

I do have a question for you because no one has ever answered this yet. Can Passavant move into the home before the Zoning Board has reached their final decision, knowing that Passavant will conduct their business with three patients, plus the caregiver, direct care employee, and not having their proper permits? Please answer, how is this allowed? This is not a single family.

PRESIDENT MOURY: Thank you very much.

Jennifer Hopwood.

1 (Applause.) MS. HOPWOOD: Hi. Jennifer Hopwood, 2 3 3350 Appel Road. I'm here again for the same 4 reason, the 242 Lisa Drive. 5 I'm a single mom of two young children. Their ages are eleven and six. I 6 7 have safety concerns, as well as just 8 basically the neighborhood concern as far as the value of our neighborhood. 9 10 My oldest son currently goes to Neil 11 Armstrong. His bus stop is not very close to 12 our home. He has to walk down Appel onto Voss 13 to catch it at South Park Road. I'm concerned 14 about the traffic that this home will also 15 bring to the neighborhood. 16 I'm asking that -- this is an R-217 neighborhood. And we ask that you guys 18 withhold that, keep our neighborhood as is, 19 and vote to keep Passavant where they belong, 20 which is still within Bethel Park, just within 21 the correct zone. 22 Thank you. 2.3 PRESIDENT MOURY: Thank you very 24 much.

I'm here to talk about the same thing. And I'd like to talk about what a community living home with four adults looks like and why they are a family.

They live together for many, many years in another home. Just like your family, they are together the majority of the day. They actually are probably together more than you are with your families.

They live together. They menu plan together. They cook together. They make sure each member has their favorite meals. They go grocery shopping together. They decide what activities they're going to do, and they do them together.

They go to the zoo together. They celebrate holidays together. Just like all of our families, they celebrate one another's birthdays. They buy presents for one another.

They console one another. They support one another. They encourage one another. They live together and function as a family unit.

I'm sure a lot of them would prefer to be married, to live in a home with their own children and a spouse just like you do.

However, their disabilities are such that they require more support than that. And that, in my opinion, is the argument.

They are a family unit. And the law says that wherever a single family is permitted to live, so are they because they are a family. And that does not devalue your family at all.

Lastly, my apologies. However, it seems to me that the Municipality does not want to make the decision they know they need to make because you don't want these people yelling at you. And this is going to move to the court, making the decision.

I hope everybody's already aware of what the decision's going to be, and then you can say it's not your fault. But you're making these people bear the brunt of this.

We're fomenting hate, prejudice, bigotry,

nonsense, and ignorance about people with disabilities.

Don't make those people bear that when they move into this property and have to deal with this in their neighborhood. Stand up.

It was brought up by the other members who are here, "Where would they be if there are only four bedrooms in the house?

And if there are four patients in the house, where would the employees be sleeping?"

And it was completely answered by Passavant that they would make arrangements in the basement for the people to -- the employees to stay.

Now, I know if you do not have egress windows or a door, you cannot make a basement a living bedroom area. You also have fire concerns. You do that, and there's a fire in that house, you will be held responsible for those people dying in that basement.

We cannot -- I live at 3344 Appel. I cannot have my children live in my basement.

I would be -- that would be against the law.

So I wanted to make that point.

I also wanted to make the point that we are clearly not discriminating. There are other places, other alternative places for these people to be in Bethel Park.

Bethel Park, in general, is not discriminating. There are zones in Bethel

We're not voting on anything tonight. We have nothing on our agenda. Nor do we have anything at this point in time until the Zoning Hearing Board makes the final determination.

At this time, I would like to talk to the Solicitor, ask the Solicitor if he could maybe give a brief update. Because we, too, learned some things at the Zoning Hearing Board meeting that we weren't aware of. And if I could maybe ask the Solicitor to comment on what's going on.

SOLICITOR McTIERNAN: Yeah, I would just repeat what I said at the last meeting, to start with. Under the existing Zoning Ordinance, the definition of family includes three unrelated persons.

There is no exclusion from that definition of family simply because people have intellectual disabilities. Under either the ordinance or federal law, the Municipality
cannot exclude someone as family or say
they're a group home simply because those
individuals have intellectual disabilities if
they intend to make a permanent home.

- Now, what Passavant decided to do based -- despite that decision, is to go to the Zoning Hearing Board and ask to place three unrelated individuals -- to place four instead of three.
- AUDIENCE MEMBER: They're asking for four.
- SOLICITOR McTIERNAN: I'm sorry if I misstated.
 - They want to increase it to four.

 And they went there claiming they should get a variance.
 - The only issue in front of the Zoning Board is whether they should go from three to four. They shouldn't be considering any other issue. That was the issue that was taken to them.
 - And I have to say, I think we all learned some things from the testimony that was offered at that hearing that was not

presented initially. And some additional -
some more candor from Passavant, I think,

would have certainly been helpful to the

community.

Because as one of the speakers indicated, we always knew there were going to be staffers coming into the home to help those individuals who live there. And that is permitted in an R-1 zone.

If you have a live-in nanny, if you have a companion for an elderly relative, if you have a person who helps you with a disabled child, that's not necessarily the resident -- the residents, but they could be there and they could be sleeping there.

What we didn't know until the witness who was under oath, not the lawyer, came forth with the fact that there might be an individual -- staff people who are forced to sleep in the basement when there's no appropriate egress. And we intend to engage Passavant about that issue and other code-related issues.

Now, those aren't zoning issues.

But those are important issues that came up at

the hearing, and we intend to bring it up to them.

And I must say, you know, we've been through this issue many times in the past.

And one of the things that always helps is if the provider provides more information to the community, more outreach to explain, you know, the individuals are going to be living there, whether they have a condition that would be a threat to anyone or they have -- and I don't think that's happened with this provider.

And that has created issues for the community. It's created issues for the public officials. And we don't want to be finding things out at public hearings any more than the public does.

But that being said, we still must comply with the Zoning Ordinance, which does provide for three adults or, potentially, the issue of the Fair Housing Act.

And I beg the differ with individuals, that you cannot exclude disabled individuals -- mentally disabled individuals from residential zones R-1 or R-2 simply because they have mental handicap. That is

1 not permitted under federal law or under our
2 Zoning Ordinance.

But we don't take these issues

lightly of the indiv- -- of where the staff

people are going to be. And I've been

authorized by Council to reach out to

Passavant and engage them in some of these

DR. CAMPBELL: A lot of Public Works projects need to have some significant funding up front from the very go. You can imagine some things like road repaving projects. When we do a lot of work at the sewage treatment plant, projects that we have upgrades there.

If we do major purchases in police vehicles, Public Works vehicles, for instance, even a lot of our flood control projects, they

need -- they need funding ahead of time.

2.3

Municipal bonds are often issued by towns and cities as a way of raising revenue to -- that's earmarked for these public projects.

Because these ventures are deemed for the public -- for the greater good, greater good of the public, the interest from the municipal bonds is often free of federal, state or local taxes.

Typically, the yields for bonds are kind of low. We're talking about two to four percent, depending on the year or the month that they're offered, as well as the economic climate, the market climate at the time. But most investors are willing to forego big returns if they don't have to pay taxes on their capital gains.
