2 (Commencing at approximately 6:30 p.m.)

3 PRESIDENT OAKES: All right. I'd  
4 like to call the 6:30 Special Meeting to order  
5 for the appointment of our new police officers  
6 for the Bethel Park Police Department.

7 Chief, would you like to say -- start  
8 off by saying anything, or do you want me to  
9 kind of...

10 CHIEF ARNOLD: I don't really have  
11 much to say --

12 PRESIDENT OAKES: Okay.

13 CHIEF ARNOLD: -- other than I sent  
14 you this email this past week --

15 PRESIDENT OAKES: Yeah.

16 CHIEF ARNOLD: -- with my  
17 recommendations.

18 I still stick with them. I think  
19 they're four really, really good candidates  
20 that we have. And I'd just leave it up to you  
21 folks.

22 PRESIDENT OAKES: Perfect.

23 MR. CENCI: I'd like to say  
24 something.

25 PRESIDENT OAKES: Yeah, go ahead.

1           MR. CENCI: Chief, one thing I hope  
2           that they understand when they come here as a  
3           veteran, that they are going to start at the  
4           lowest possible. They're not going to be in  
5           traffic investigations or this other stuff  
6           when they start.

7           Do they understand that?

8           CHIEF ARNOLD: As --

9           MR. CENCI: The new people.

10          CHIEF ARNOLD: -- probationary  
11          employees?

12          MR. CENCI: Yeah.

13          Their last department, they might be  
14          specialized in all this stuff. When they come  
15          here, maybe down the road they are. But  
16          they're going to start out as a patrol person.

17          CHIEF ARNOLD: I haven't had any  
18          conversations like that with any of the  
19          applicants, but --

20          MR. CENCI: Okay. I hope they don't  
21          think that as soon as they come here they're  
22          going to be put into a special unit --

23          CHIEF ARNOLD: I mean --

24          MR. CENCI: -- the next day.

25          CHIEF ARNOLD: -- that wouldn't

1       happen on my behalf.

2               MR. CENCI:    Okay.   Well, that's --  
3       well, that's all --

4               CHIEF ARNOLD:   We wouldn't be doing  
5       that.

6               MR. CENCI:    Yeah.

7               CHIEF ARNOLD:   I mean, that would be  
8       something that --

9               MR. CENCI:    Yeah.   Okay.

10              CHIEF ARNOLD:   -- they would have to  
11       deal --

12              MR. CENCI:    Yeah.   Okay.   That's all.

13              CHIEF ARNOLD:   -- with, yeah.

14              PRESIDENT OAKES:   Can we get a flag  
15       up on the screen?

16              MS. DENNE:    Actually, I have one up  
17       on here...

18              PRESIDENT OAKES:   So, real quick,  
19       while we're working on that.

20              So, the recommendations are as  
21       follows from Chief:   It's going to be officers  
22       Halaszynski, Hoover, McKown, and then  
23       Christine Platt would be -- the first three  
24       were our preferred veterans.   And then the  
25       fourth would be the choice, Christine Platt

1 from Castle Shannon, just so everyone knows.

2 That being said, do we want to start  
3 a roll call for this Special Meeting?

4 MS. DENNE: Hold on one second.

5 PRESIDENT OAKES: Yeah.

6 MS. DENNE: I'm just opening up.

7 PRESIDENT OAKES: No problem.

8 - - -

9 (Whereupon, an off-the-record  
10 discussion took place.)

11 PRESIDENT OAKES: Chief, would they  
12 know right after the meeting? Are you going  
13 to let them know, like, right after the  
14 meeting? Is that --

15 CHIEF ARNOLD: Yeah, I'll --

16 PRESIDENT OAKES: Okay.

17 CHIEF ARNOLD: -- go down and give  
18 them a call and let them know that they have a  
19 conditional offer. And then there's a couple  
20 more steps, physical, psychological, drug  
21 screening, hearing, and vision. They have to  
22 pass all that before they can start.

23 So, this is a conditional offer. If  
24 they pass all that, they'll be good.

25 PRESIDENT OAKES: Perfect. Perfect.

1 All right. Mr. Espinar, so you know,  
2 the first three were veterans, so we had to  
3 take them. And the fourth, there was a couple  
4 choices.

5 Ms. Platt had a bunch of different  
6 experience from Castle Shannon, including  
7 vehicle crash reconstruction, and also the  
8 commercial vehicle enforcement licenses.

9 So, anyways, roll call, please.

10 MS. DENNE: Yes.

11 Mr. Consolmagno?

12 MR. CONSOLMAGNO: (No response.)

13 MS. DENNE: Ms. Kamenicky?

14 MS. KAMENICKY: Here.

15 MS. DENNE: Mr. Oakes?

16 MR. OAKES: Here.

17 MS. DENNE: Mr. Cenci?

18 MR. CENCI: Yes.

19 MS. DENNE: Mr. Janosik?

20 MR. JANOSIK: Here.

21 MS. DENNE: Mr. Jenkins?

22 MR. JENKINS: Here.

23 MS. DENNE: Mr. Espinar?

24 MR. ESPINAR: Here.

25 MS. DENNE: Ms. Garis?

1 MS. GARIS: Here.

2 MS. DENNE: Ms. Flinn?

3 MS. FLINN: Here.

4 PRESIDENT OAKES: Eight members  
5 present.

6 Could we please stand for the Pledge  
7 of Allegiance.

9 (Whereupon, the Pledge of Allegiance  
10 was recited.)

11 PRESIDENT OAKES: Is there any  
12 comments from Council? Or anyone, for that  
13 matter?

14 (No response.)

15 PRESIDENT OAKES: No comments.

16 We'll move right on to the agenda.

17 Accept Civil Service Eligibility  
18 List to Appoint New Hires for the Police  
19 Department.

20 I move to accept the Civil Service  
21 eligibility list for police candidates.

22 Do I have a second?

23 MR. JANOSIK: Second.

24 PRESIDENT OAKES: Second from  
25 Mr. Janosik.

1 Roll call, please.

2 MS. DENNE: I'm sorry. Who was the  
3 motion and the second?

4 PRESIDENT OAKES: Motion was from  
5 Mr. Oakes, second from Mr. Janosik.

6 Is the president allowed to make the  
7 motion?

8 SOLICITOR McTIERNAN: I mean, it's  
9 not traditional, but you can. There's no  
10 reason --

11 MR. CENCI: Yeah, it's not  
12 traditional.

13 SOLICITOR McTIERNAN: You can make  
14 the motion.

15 PRESIDENT OAKES: Roll call, please.

16 MS. DENNE: Mr. Cenci, our Roberts  
17 Rules of Order expert.

18 MR. JANOSIK: He'll read the next  
19 four.



