**APPLICANT: SPIRIT HALLOWEEN STORE** 

**LOCATION:** 4000 OXFORD DRIVE

SUBJECT: DIMENSIONAL VARIANCE TO EXCEED THE AMOUNT OF WINDOW

COVERAGE ALLOWED IN ORDER TO ADVERTISE A BUSINESS

It is hereby requested that the Zoning Hearing Board hear an application for a variance. The land involved is 4000 OXFORD DRIVE. <u>Current Zoning Classification</u>: C-2 <u>Involved ordinance</u> <u>or Legislative Act</u>: Ord. 7-12-93A <u>Section</u>: 69.53D.2.

Variance Type: Dimensional

Request to exceed window coverage allowance for a store sign.

#### **Applicant's Petition:**

Seeking a variance due to the hardship created by the difference in wall mounted vs. window covered sign ordinances. The storefront is made up of almost entirely windows and a variance is requested to use more window space to advertise the business.

### **Applicant's Arguments:**

Storefront is made up of majority of windows with little wall space for mounting signs. Proposed sign was reduced from covering all of the windows to the image presented.
