APPLICANT: MARIE HAMMER

LOCATION: 427 PATTERSON ROAD

SUBJECT: USE VARIANCE TO OPERATE A GROUP DAY CARE HOME

It is hereby requested that the Zoning Hearing Board hears an application for a variance. The property involved is 427 Patterson Road. **Current Zoning Classification:** R-3 **Involved ordinance or Legislative Act:** Ord. 7-12-93A **Section:** 69.8.68.9

Variance Type: Use

Request to operate a fully licensed in-home group childcare center for up to nine (9) children. Current R-3 zoning ordinance allows for up to six (6) children.

Applicant's Petition:

Safe, reliable childcare is extremely difficult to find in our area. This program will not alter the residential character of the property. There are adequate (5) off-street parking spots. Noise levels will be minimal and comparable to those of a typical family home. All local and state regulations will be followed at all times. The residence will also receive an occupancy permit for a group childcare in-home center.

Applicant's Arguments:

I am already zoned R-3 which allows six (6) children. I just need a variance to allow up to three (3) additional children with three (3) full-time teachers.
