

# **CMHA Award Means New Senior Housing**

**Cincinnati** – Cincinnati Metropolitan Housing Authority (CMHA) has been awarded Low Income Housing Tax Credits from Ohio Housing Finance Agency for the development known as *West Union Square located in Colerain Township*. This Tax Credit award advances the joint efforts of CMHA and Colerain Township and will make a significant economic impact for the community and Hamilton County.

There is a strong need for senior housing in Hamilton County and *West Union Square* will be made of 70 units of affordable housing dedicated to persons age 55 and above. The site is well located to serve the intended elderly population due to its proximity to shopping, services, transportation and banks. "CMHA is pleased to be working with Colerain Township to develop a community that meets the needs of its residents while also helping to revitalize the township," said CMHA Chief Executive Officer Gregory D. Johnson.

Demolition at the site has already helped stabilize the township. "This project started in 2013 as a private/public partnership with a shared vision of revitalizing a depressed neighborhood plagued by crime and foreclosure," said Colerain Township Administrator Jim Rowan. West Union Square is projected to generate an estimated economic impact of \$12-14 million in construction. And with new construction comes new jobs.

West Union Square will consist of 58 one-bedroom units and 12 two-bedroom units, a community and theatre room as well as ample outdoor recreational space.
