

The Board of Trustees of Colerain Township, County of Hamilton, State of Ohio, met in regular session at 5:30^{pm}, on the 15th day of November, 2016, at the Colerain Township Administration Building, 4200 Springdale Road, Cincinnati, Ohio 45251, with the following members present:

Mr. Ritter introduced the following resolution and moved its adoption:

RESOLUTION NO. 55 -16

RESOLUTION ACCEPTING FOREST VALLEY DRIVE AS A COLERAIN TOWNSHIP ROAD

WHEREAS, the Hamilton County Engineer has requested that Forest Valley Drive, a 757.45 L.F. road located in Stone Ridge Estates Subdivision, Section Three Block B, Colerain Township, Hamilton County, Ohio be established as a Township road; and

WHEREAS, the Colerain Township Board of Trustees agrees to accept and establish Forest Valley Drive as a Township road in Colerain Township in its current condition; and

NOW, THEREFORE, BE IT RESOLVED BY THE COLERAIN TOWNSHIP BOARD OF TRUSTEES, THAT:

1. The Colerain Township Board of Trustees authorizes the Township Administrator to execute any documents or agreements necessary in order to establish Forest Valley Drive as a Township road.
2. That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal action were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.
3. That the Board by a majority vote hereby dispenses with the requirement that this Resolution be read on two separate days, pursuant to Section 504.10 of the Ohio Revised Code, and hereby authorizes the adoption of the Resolution upon its first reading.
4. This Resolution shall take effect on the earliest date permitted by law.

Mr. Inderhees seconded the Resolution, and the roll being called upon the question of its adoption, the vote resulted as follows:
