"National Electric Code, 2008 Edition, (NFPA 70-2008)" issued by the Standards Council of the National Fire Protection Association, Inc., on July 26, 2007, effective August 15, 2007, and approved as an American National Standard on August 2, 2001, together with the annexes, the appendices and indices forming a part thereof, save and except those portions thereof as shall be deleted, modified, amended or extended.

It is further directed that there shall be provided and on file in the office of the City Clerk of the City of Decatur not less than three (3) copies of such code for a period of not less than fifteen (15) days prior to the holding of such public hearing for use and examination by the public.

Notice of the time, place and purpose of such hearing shall be given by publication of this resolution at least fifteen (15) days prior to the date of said hearing, once a week for two successive weeks in THE DECATUR DAILY, a newspaper published and of general circulation in Decatur, Alabama.

CODE Chapter 7 - BUILDINGS AND BUILDING REGULATIONS ARTICLE V. - ELECTRICITY DIVISION 2. - ELECTRICIAN'S LICENSE

ORDINANCE NUMBER 12-4122

BE IT ORDAINED by the City Council of Decatur, Alabama as follows:

Section 1. That section 7-121 of the Code of Decatur, Alabama is hereby amended to read as follows:

"Sec. 7-121. - Code adopted; amendments.

Pursuant to the authority granted cities and towns by section 11-45-8 Code of Alabama, 1975, there is hereby adopted that certain code printed in book or pamphlet form known as follows: "National Electric Code, 2008 Edition, (NFPA 70-2008)" issued by the Standards Council of the National Fire Protection Association, Inc., on July 26, 2007, effective August 15, 2007, and approved as an American National Standard on August 2, 2001, together with the annexes, appendices and indices forming a part thereof, save and except the following portions thereof as shall be deleted, modified, amended:

- (1) Annex A- Product Safety Standards; Annex B- Application Information for Ampacity Calculations; Annex C Conduit and Tubing Fill Tables for Conductors and Fixture Wire of the Same Size; Annex D- Examples; Annex E- Type of Construction; Annex F- Availability and Reliability for Critical Operations Power Systems; and Development and Implementation of Functional Performance Test (FPTs) for Critical Operations Power Systems; and Annex G-Supervisory Control and Data Acquisition (SCADA) are all adopted as informative and as guidelines in the interpretation of the Code, and not adopted as part of the Code.
- (2) Annex H- Administration and Enforcement is not adopted as part of the Code and is deleted in its entirety."
