Sturges-Young to Celebrate 50 Years

It's hard to believe, but Sturges-Young Civic Center and Auditorium is nearly 50 years old! On May 15, 50 years to the day after the auditorium was originally presented to the people of the City of Sturgis, a rededication ceremony will take place. As the community embarks on this special occasion, here's a look at the auditorium's past and its future:

Making it all possible

On October 13, 1952, Sturgis City Commissioners gratefully received an approximate \$300,000 legacy from the estate of Emma D. Young. It was her wish that the money be used for the benefit of the people of the community, and in particular, for an auditorium.

From there, Mayor Parker appointed an auditorium board of nine members: Flora Kirsch, William Stapleton, Margaret Brunson, Lee Barnell, Robert Pfeiffer, Lawrence Cherrington, Leo Yoder, George Freeman, chairman, and the mayor himself.

These board members decided to locate the auditorium on the northeast corner of North Nottawa and West Streets. Sturgis Public Schools owned two lots at this location which they generously donated to the City of Sturgis in order to facilitate the plan. All other property needed for the project was purchased by the City.

After consulting with civic clubs, local schools, and other organizations regarding the various possible uses of a civic center and auditorium, the board met with several architects, and ultimately chose the firm of A.M. Strauss, Inc. to design the preliminary plans. When the initial building plans were estimated to cost \$570,000, almost twice the amount of the bequest, there ensued a lengthy discussion concerning deletions and substitutions. The revised plans reduced the estimated cost to \$470,000, however still \$170,000 too much.

In October of 1953 William Stapleton, the new chairman, reported that additional funds for the auditorium building project would be available via a trust fund established by two sisters, Stella Sturges-Taylor and Clara Sturges. Later an additional \$25,000 was added from the sale of property owned by the late Emma Young.

The contractor bids were opened on March 4, 1954, and construction began shortly thereafter. The general construction was done by Miller Davis Company of Kalamazoo. Fordec-Kemerly Electric and Frank Casselman, both of Sturgis, were two other companies involved in the original building project. The remainder of the year was spent by the board in meetings: approving changes; paying contractors; designing the kitchens, theatre, and dining rooms; and establishing the auditorium's policies and rental rates.

R.H. Shepherd was the first manager of Sturges-Young Civic Center and Auditorium. A public dedication and open house was held Sunday, May 15, 1955. And so because of three women's generosity and futuristic thinking Sturges-Young Civic Center and Auditorium came to exist.

Making it last

While Emma Young, Stella Sturges-Taylor and Clara Sturges saw a need for a building like Sturges-Young Civic Center and Auditorium, 50 years later, members of the community are seeing the need for the building to continue for another half a century and beyond.

A 50th anniversary committee has formed in hopes of raising needed funds for renovations at Sturges-Young. The group has hosted a handful of events including dinner/dances and a Kingdom Heirs show in hopes of raising not only funds, but awareness about the facility's capabilities. A seat campaign is also currently underway. Donors of \$200-\$300, depending on the number of seats donated for, will be recognized with a brass nameplate affixed to a seat in the auditorium. The donation will allow for the complete restoration of the seat, plus donors will be remembered by the community for generations to come.

The seat campaign is just one way to contribute to the auditorium's 50th anniversary campaign as several renovations are needed. Approximately \$2.5 million is being sought for renovations including a computerized front sign, a sound system throughout the Civic Center, internet capability in each room, kitchen equipment, parking lot resurfacing and expansion, an HVAC system and downstairs renovations.

SPRING 2005 HYDRANT FLUSHING SCHEDULE

The City of Sturgis Department of Public Services will be flushing hydrants in April according to the following schedule. This schedule is tentative and subject to weather conditions.



TUESDAY, APRIL 19th - THE AREA SOUTH OF EAST CHICAGO ROAD AND EAST OF SOUTH NOTTAWA STREET.

WEDNESDAY, APRIL 20th - THE AREA SOUTH OF WEST CHICAGO ROAD AND WEST OF SOUTH NOTTAWA STREET.

THURSDAY, APRIL 21st - THE AREA NORTH OF EAST CHICAGO ROAD AND EAST OF NORTH NOTTAWA STREET.

FRIDAY, APRIL 22nd - THE AREA NORTH OF WEST CHICAGO ROAD AND WEST OF NORTH NOTTAWA STREET TO NORTH CENTERVILLE ROAD.

Spring Clean-up Planned

Have a large item to get rid of? You're in luck. The City's annual Large Item Spring Clean-up is just around the corner.

In preparation for Michigan Week activities, the pickup date for residents NORTH of Chicago Road will take place Saturday, April 30, while the pickup date for residents located SOUTH of Chicago Road will be Saturday, May 7. On the date scheduled for your area, place items near the curb in front of your property. The City asks that residents do not place any items in the street itself.

Also, due to environmental concerns, residents wishing to dispose of any item containing Freon (refrigerators, freezers, air conditioners, dehumidifiers, etc.) will need to follow specific instructions. These items must have the Freon removed by a certified professional before they can be disposed of legally. Residents can call or stop in at Camburn Appliance, 411 N. Nottawa St., and register their appliances. There will be a \$35 fee per appliance for the service. After registering, Camburn Appliance will come to your home and remove the Freon from the item or items. They will then put a sticker on the appliance stating the Freon has been properly removed. You may then place these items near the curb for disposal on the appropriate pickup date. The City WILL NOT pick up any appliance containing Freon that does not have a Camburn Appliance sticker showing workers the Freon has been properly disposed of.

Again this year the DPS will be picking up used tires, however due to costs for disposal the department will charge a fee of \$2 per tire for automobile sized tires and \$5 per tire for semi truck sized tires. Citizens wishing to have tires picked up should pre-pay for the service at the City Clerk's office before their pickup date. Please remember tires must be separated from the wheel.

Tree Work Underway ... Request Your Plantings Today

City crews are currently in the process of trimming 135 trees within the City limits and have removed 32 trees. Line clearance for the Electric Department is also underway with cutting to begin in the coming month. Trees marked with a dot are scheduled to be trimmed. Those marked with an ex are to be removed. Property owners affected by removals will be contacted before removal takes place. Crews are also taking requests for spring terrace tree plantings. Last fall they planted more than 250 trees in the city terrace, or the area between the street and sidewalk. Help Keep Sturgis Beautiful!

Do your part to help keep Sturgis beautiful. Please obey the following City of Sturgis ordinances and report any violations of those ordinances to Code Enforcement Officer Rick L. Sweitzer at 659-7215.

It is the responsibility of the owner and occupant of any lot, land or premises within the corporate limits of the City to:

- * not park any vehicle in the front yard of the property unless in an approved area.
- * not park any vehicle on the property in an unapproved area when selling a vehicle.
- * not allow any vehicle to remain parked or stored on the property that is unlicensed or inoperable.
- * cut and remove, or cause to be cut and removed, all weeds or plant growth in excess of ten inches.
- * remove any garbage or rubbish that has been stored, collected, kept or placed on the property for more than twenty-four (24) hours.



Notes on Brush and Grass Clippings

Brush and/or grass clippings should be removed from the street to eliminate traffic hazards and storm water collection problems. Brush may not be placed in the street, but can be placed on the terrace (generally the area between the pavement and sidewalk). This should be done no sooner than 48 hours before brush pickup which begins on the Monday morning of the first full week of each month from April to October. Grass clippings and brush can also be taken to the compost site during the months of April through October. The compost site is open noon-7:30 p.m. Mondays and Thursdays and 9 a.m.-5 p.m. Saturdays.

Commissioners Outline Goals: Roads a Top Priority

Sturgis City Commissioners adopted their 2005-2006 goals during a recent planning session and once again named streets as one of their top priorities. Last year they spent more on streets than any other year in recent history when they spent \$211,000. In order to continue a street repair program the City Commission has considered a number of funding options; a recent study shows that Sturgis needs a minimum of \$12 million in street repairs. In 2002, a millage was placed on the ballot, but failed to pass. Additionally, each year the budget is reviewed to see if additional funding could be allocated for street repair. Most recently, at its annual planning retreat, the City Commission directed City staff to consider bonding to fund a large project that will make a significant impact on our street system.
