**1.00 SUBMISSION OF PROPOSAL**

Proposals along with vendor proposal form can be submitted to the Program Manager, Farmington Civic Center – 2 Black Knight Drive, Farmington, Missouri, 63640. Each proposal must be clearly marked as a proposal for Youth Sports Photography - Farmington Parks and Recreation.

The deadline for proposals is 2:00 p.m., December 15, 2022. No proposal will be accepted after the deadline for submission of proposals, regardless of the reason for such lateness, and will be returned to sender unopened.

**2.00 QUESTIONS AND INTERPRETATIONS**

For clarity and purposes of ensuring a fair and open selection process, all submitted questions and responses will be forwarded to all proposers.

**3.00 MODIFICATIONS TO PROPOSALS**

Proposals may be withdrawn or modified in writing prior to the proposal submission deadline. All changes and/or additions to this request for proposals will be made in the form of a written addendum.

**5.00 REQUESTED SERVICES**
