City Council Minutes of Meeting April 12, 2012 6:30 p.m.

The City Council of the City of Farmington met on April 12, 2012 at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Stuart Landrum.

Mayor Landrum gave the invocation.

The roll was called with the following Councilmen present: Corey Gibson, Dennis Smith, Joe McMillen, Mark Kellogg, Darrel Holdman, Lynn Crites, and Larry Forsythe. John Robinson was absent.

City Counselor Scott Reid was present.

Councilman Holdman made a motion to approve the agenda, seconded by Councilman Kellogg, and passed unanimously.

Reports were given by Committee Chairs and the City Administrator with Council discussion.

Mayor Landrum presented a proclamation for National Library Week to Lynn Crites, Travis Trokey, and Bonnie Coleman.

Travis Trokey gave a presentation on the new eBooks program at the Library.

Councilman Holdman made a motion to approve the Consent Agenda, seconded by Councilman Kellogg, and passed unanimously.

Councilman Holdman made a motion for the first reading by title only on Bill 30042012, seconded by Councilman Smith, and passed unanimously.

Counselor Reid read the following Bill once by title only.

BILL 30042012: AN ORDINANCE APPROVING AND ACCEPTING THE FINAL SUBDIVISION RECORD PLAT OF ROCKWOOD APARTMENTS, A SUBDIVISION OF THE CITY OF FARMINGTON.
