City Council Minutes of Meeting May 29, 2012 6:30 p.m.

The City Council of the City of Farmington met on May 29, 2012 at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Stuart Landrum.

Mayor Landrum gave the invocation.

Councilman Holdman made a motion to approve the agenda, seconded by Councilman Smith, and passed unanimously.

Reports were given by Committee Chairs and the City Administrator with Council discussion.

Councilman Smith made a motion to hire a new police officer, Ryan Miller, seconded by Councilman Crites, and passed unanimously.

Councilman Holdman made a motion to approve the Consent Agenda, seconded by Councilman McMillen, and passed unanimously.

Councilman Holdman made a motion for the second reading by title only and Council action on Bill 33052012, seconded by Councilman Smith, and passed unanimously.

Mayor Landrum read the following Bill once by title only.
