City Council Minutes of Meeting July 23, 2012 6:30 p.m.

The City Council of the City of Farmington met on July 23, 2012 at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Stuart Landrum.
