## **CITY OF FARMINGTON**

City Council Minutes of Meeting October 11, 2012 6:30 p.m.

The City Council of the City of Farmington met on October 11, 2012 at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Stuart Landrum.

Mayor Landrum gave the invocation.

The roll was called with the following Councilmen present: Darrel Holdman, Mark Kellogg, Joe McMillen, Dennis Smith, Corey Gibson, John Robinson, Larry Forsythe, and Lynn Crites.

City Counselor, Scott Reid, was present.

Councilman Holdman made a motion to approve the agenda, seconded by Councilman McMillen, and passed unanimously.

Reports were given by Committee Chairs and the City Administrator with Council discussion.

Councilman Holdman made a motion for the City to reimburse St. Francois County for the installation of the sprinkler system, based off the bids they receive, seconded by Councilman Smith, and passed unanimously.

Councilman Holdman made a motion for a voice vote to pass a resolution at the next City Council meeting to lift the residency requirement for City employees, with the exception of the City Administrator, Police Chief, Public Works Director, and Fire Department, seconded by Councilman Forsythe, and passed unanimously.

Councilman Holdman made a motion to approve the Consent Agenda, seconded by Councilman Kellogg, and passed unanimously.

Councilman Holdman made a motion for the second reading by title only and Council Action on Bill 60092012, seconded by Councilman Smith, and passed unanimously.

Counselor Reid read the following Bill once by title only.
