

CITY OF FARMINGTON

City Council Minutes of Meeting January 10, 2013 6:30 p.m.

The City Council of the City of Farmington met on January 10, 2013 at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Stuart Landrum.

Mayor Landrum gave the invocation.

The roll was called with the following Councilmen present: Dennis Smith, Corey Gibson, John Robinson, Larry Forsythe, Lynn Crites, Darrel Holdman, Mark Kellogg, and Joe McMillen.

City Counselor, Scott Reid, was present.

Councilman Holdman made a motion to approve the agenda, seconded by Councilman Kellogg, and passed unanimously.

Reports were given by Committee Chairs and the City Administrator with Council discussion.

Councilman McMillen made a motion for a 90-day trial for a stop sign at the intersection of Dawn Street (southbound) and Hawthorn Street, seconded by Councilman Holdman, and passed unanimously.

Councilman Holdman made a motion to approve the Consent Agenda, seconded by Councilman Kellogg, and passed unanimously.

Councilman Holdman made a motion for the second reading by title only and Council action on Bill 78122012, seconded by Councilman Smith, and passed unanimously.

Counselor Reid read the following Bill once by title only.

BILL 78122012-ORDINANCE 5-181: AN ORDINANCE VACATING PART OF A STREET RIGHT-OF-WAY (POTOSI STREET).
