City Council Minutes of Meeting January 28, 2013 6:30 p.m.

The City Council of the City of Farmington met on January 28, 2013 at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Stuart Landrum.
