

# CITY OF FARMINGTON

## City Council Minutes of Meeting March 25, 2013 6:30 p.m.

The City Council of the City of Farmington met on March 25, 2013 at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Stuart Landrum.

Mayor Landrum gave the invocation.

The roll was called with the following Councilmen present: Larry Forsythe, Lynn Crites, Darrel Holdman, Mark Kellogg, Joe McMillen, Dennis Smith, and Corey Gibson. John Robinson was absent.

City Counselor, Scott Reid, was present.

Officials present were: Greg Beavers, Tim Barnes, Karen Roman, Todd Mecey, Michelle Daniel, Floyd Massey, and Paula Cartee.

Councilman Holdman made a motion to approve the agenda, seconded by Councilman McMillen, and passed unanimously.

Reports were given by Committee Chairs and the City Administrator with Council discussion.

Councilman Smith made a motion to move the vote on the annexation ordinances from May 9 to April 11 to allow Councilman McMillen to be a part of the discussion and vote, seconded by Councilman Forsythe, and passed unanimously.

Councilman Holdman made a motion to approve the Consent Agenda, seconded by Councilman Kellogg, and passed unanimously.

Councilman Holman made a motion for the second reading by title only and Council action on Bill 13022013, seconded by Councilman Smith, and passed unanimously.

Counselor Reid read the following Bill twice by title only.


