City Council Minutes of Meeting June 24, 2013 6:30 p.m.

The City Council of the City of Farmington met on June 24, 2013 at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Mit Landrum.

BILL 43062013-ORDINANCE 1-565: AN ORDINANCE GRANTING APPROVAL TO EAST MISSOURI ACTION AGENCY, INC, FOR THE PLANNED UNIT DEVELOPMENT/ PLAT APPROVAL FOR FRIENDSHIP SUBDIVISION. BILL 46062013: AN ORDINANCE EXTENDING A TAX FOR CAPITAL IMPROVEMENT ON ALL SELLERS FOR THE PRIVELEGE OF ENGAGING IN THE BUSINESS OF SELLING TANGIBLE PERSONAL PROPERTY OR RENDERING TAXABLE SERVICES AT RETAIL AT THE RATE OF ONE-HALF OF ONE PERCENT (0.5%) ON THE RECEIPTS FROM THE SALE AT RETAIL OF ALL TANGIBLE PERSONAL PROPERTY OR TAXABLE SERVICE AT RETAIL WITHIN SAID CITY, IF SUCH PROPERTY AND SERVICES ARE SUBJECT TO TAXATION BY THE SAID STATE OF MISSOURI UNDER THE PROVISIONS OF SECTIONS 144.010 TO 144.510 R.S.MO., PURSUANT TO THE AUTHORITY GRANTED BY AND SUBJECT TO THE PROVISIONS OF SECTION 94.577 R.S.MO. AND PROVIDE FOR SUBMISSION OF THIS ORDINANCE TO THE QUALIFIED VOTERS OF SAID CITY FOR THEIR APPROVAL AT THE MISSOURI GENERAL ELECTION AND TO BE HELD IN THE STATE OF MISSOURI AND CITY OF FARMINGTON ON NOVEMBER 05, 2013.

Councilman Kellogg made a motion for the reading of Resolution R05-2013, seconded by Councilman Smith, and passed unanimously.

RESOLUTION R05-2013: A RESOLUTION FOR THE PURPOSE OF APPOINTING A MEMBER TO SERVE ON THE BOARD OF DIRECTORS OF THE INDUSTRIAL DEVELOPMENT AUTHORITY OF THE CITY OF FARMINGTON, MISSOURI.

The resolution passed unanimously.

Councilman Forsythe made a motion to adjourn, seconded by Councilman Crites, and passed unanimously.
