## **CITY OF FARMINGTON**

City Council Minutes of Meeting November 25, 2013 6:30 p.m.

The City Council of the City of Farmington met on November 25, 2013 at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Landrum.

Mayor Landrum gave the invocation.

Councilman Holdman made a motion to approve the agenda, seconded by Councilman Kellogg, and passed unanimously.

Reports were given by Committee Chairs and City Administrator with Council discussion.

Councilman Kellogg made a motion to issue the annual year-end employee incentive cards (Wal-Mart Gift Cards), seconded by Councilman Crites, and passed unanimously.
