City Council Minutes of Meeting February 13, 2014 6:30 p.m.

The City Council of the City of Farmington met on February 13, 2014 at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Landrum.

Mayor Landrum gave the invocation.

The roll was called with the following Councilmen present: John Robinson, Larry Forsythe, Lynn Crites, Darrel Holdman, Mark Kellogg, Garett Boatright, Dennis Smith, and David Holman.

City Counselor, Scott Reid, was present.

Councilman Holdman made a motion to approve the agenda, seconded by Councilman Kellogg, and passed unanimously.

Larry Forsythe exited the meeting at 6:35 p.m.

Todd Mecey, Fire Chief, briefed the Council on the bids for a new fire truck. He also explained the proposals for financing.

Larry Forsythe re-entered the meeting at 6:40 p.m.

Michele Daniel, Finance Director, gave a financial overview to the Council.

Reports were given by Committee Chairs and City Administrator with Council discussion.

Councilman Holdman made a motion to approve the Consent Agenda, seconded by Councilman Kellogg, and passed unanimously.
