City Council Minutes of Meeting April 28, 2014 6:30 p.m.

The City Council of the City of Farmington met on April 28, 2014 at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Landrum.

Mayor Landrum gave the invocation.

Councilman Holdman made a motion to approve the agenda, seconded by Councilman Boatright, and passed unanimously.

Reports were given by Committee Chairs, City Administrator, and Finance Director with Council discussion.

Councilman Holdman made a motion to approve the Consent Agenda, seconded by Councilman Boatright, and passed unanimously.

Councilman Boatright made a motion for the second reading by title only and Council action on Bill 2804204, seconded by Councilman Smith, and passed unanimously.
