## CITY OF FARMINGTON

City Council Minutes of Meeting April 9, 2015 6:30 p.m.

The City Council of the City of Farmington met on April 9, 2015, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Landrum.

Mayor Landrum gave the invocation.

The roll was called with the following Councilmen present: David Holman, John Robinson, Larry Forsythe, Lynn Crites, Darrel Holdman, Mark Kellogg, Garret Boatright and Dennis Smith.

City Counselor, Scott Reid, was present.

Councilman Holdman made a motion to approve the agenda, seconded by Councilman Kellogg, and passed unanimously.

Reports were given by Committee Chairs and City Administrator with Council discussion.

Councilman Smith made a motion to approve the promotion of LeRoy Beard to Sergeant and Brad Williams to Corporal, seconded by Councilman Forsythe, and passed unanimously.

Councilman Holdman made a motion to approve the consent agenda, seconded by Councilman Kellogg, and passed unanimously.

Councilman Holdman made a motion for the second reading by title only and Council action on Bill 20032015, seconded by Councilman Smith, and passed unanimously.

Counselor Reid read the following Bill once by title only.
