City Council Minutes of Meeting April 27, 2015 6:30 p.m.

The City Council of the City of Farmington met on April 27, 2015, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Pro-Tem, Dennis Smith.

Councilman Robinson gave the invocation.

The roll was called with the following Councilmen present: David Holman, John Robinson, Larry Forsythe, Lynn Crites, Darrel Holdman, Garret Boatright and Dennis Smith.

City Counselor, Scott Reid, was present.

Officials present were: Greg Beavers, Michelle Daniel, Paula Cartee, Dylan Mosier, Todd Mecey, Floyd Massey, and Larry Lacy.

Councilman Holdman made a motion to approve the agenda, seconded by Councilman Boatright, and passed unanimously.

Chuck Henson, First Baptist Church, informed the Council about their mission project, "You are the Light", that will take place June 22-26, 2015.

Reports were given by Committee Chairs and City Administrator with Council discussion.

Councilman Holdman made a motion to approve the consent agenda, seconded by Councilman Boatright, and passed unanimously.

Councilman Boatright made a motion for the second reading by title only and Council action on Bill 21042015, seconded by Councilman Holdman, and passed unanimously.

Counselor Reid read the following Bill once by title only.

BILL 21042015-ORDINANCE 3-72: AN ORDINANCE TO ENABLE THE CITY OF FARMINGTON, MISSOURI TO JOIN THE MISSOURI CLEAN ENERGY DISTRICT PURSUANT TO SECTIONS §67.2800 TO §67.2835, INCLUSIVE, RSMO., THE "PROPERTY ASSESSED CLEAN ENERGY ACT," AND STATING THE TERMS UNDER WHICH THE CITY WILL CONDUCT ACTIVITIES WITHIN THE CITY AS A MEMBER OF SUCH DISTRICT.

BILL 29042015: AN ORDINANCE OF THE CITY OF FARMINGTON, MISSOURI, APPROVING THE SECOND AMENDMENT TO THE FISCAL YEAR 2015 OPERATING BUDGET AND AUTHORIZING THE EXPENDITURES CONTAINED THEREIN.
