City Council Minutes of Meeting November 12, 2015 6:30 p.m.

The City Council of the City of Farmington met on November 12, 2015, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Landrum.

Mayor Landrum gave the invocation.

The roll was called with the following Councilmen present: John Robinson, Larry Forsythe, Lynn Crites, Darrel Holdman, Mark Kellogg, Garrett Boatright, Dennis Smith and John Crouch.

City Counselor, Scott Reid, was present.

Officials present were: Greg Beavers, Larry Lacy, Rick Baker and Paula Cartee.

Councilman Holdman made a motion to approve the agenda, seconded by Councilman Kellogg, and passed unanimously.

Andrew Hamill, Overton Street, addressed the Council suggesting the fee for failure to appear be set at \$9.95.

Reports were given by Committee Chairs and City Administrator with discussion.

Councilman Holdman made a motion to approve the consent agenda, seconded by Councilman Kellogg, and passed unanimously.

Councilman Kellogg made a motion for the first reading by title only and Council action on Bill 66112015, seconded by Councilman Smith, and passed unanimously.

Counselor Reid read the following Bill once by title only.

BILL 66112015: AN ORDINANCE OF THE CITY OF FARMINGTON, MISSOURI, AMENDING THE MUNICIPAL CODE OF THE CITY OF FARMINGTON, CHAPTER 125. MUNICIPAL COURT, ARTICLE III. PROCEDURE, SECTION 125.180. FAILURE TO APPEAR UPON ARREST OR SUMMONS – PENALTY.


Councilman Kellogg made a motion for the first reading by title only and Council action on Bill 67112015, seconded by Councilman Smith, and passed unanimously.

Counselor Reid read the following Bill once by title only.

BILL 67112015: AN ORDINANCE AMENDING THE MUNICIPAL CODE OF THE CITY OF FARMINGTON, MISSOURI, BY AMENDING TITLE IV: LAND USE, CHAPTER 420: STORMWATER MANAGEMENT REGULATIONS, A LAND USE KNOWN AS "STORMWATER MANAGEMENT PLANS AND STORMWATER MANAGEMENT REGULATIONS": AND ENACTING CERTAIN REGULATIONS PERTAINING THERETO.


Councilman Forsythe made a motion to adjourn, seconded by Councilman Crites, and passed unanimously.
