## **CITY OF FARMINGTON**

City Council Minutes of Meeting February 12, 2015 6:30 p.m.

The City Council of the City of Farmington met on February 12, 2015, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Landrum.

Mayor Landrum gave the invocation.

The roll was called with the following Councilmen present: Garret Boatright, Dennis Smith, David Holman, John Robinson, Larry Forsythe, Darrel Holdman and Mark Kellogg.

Councilman Lynn Crites was absent.

City Counselor, Scott Reid, was present.

Officials present were: Greg Beavers, Michelle Daniel, Todd Mecey, Floyd Massey, Paula Cartee, and Larry Lacy.

Councilman Holdman made a motion to approve the agenda, seconded by Councilman Kellogg, and passed unanimously.

Kurt Bauche addressed the Council regarding the possibility of purchasing a baby grand piano for the Centene Center. The Council agreed to discuss the purchase in the Public Services Committee meeting. The Council recommended a partnership with the community. Kurt Bauche agreed to lead a fundraiser to help fund the purchase.

Michelle Daniel, Finance Director, provided a financial overview.

Reports were given by Committee Chairs and City Administrator with Council discussion.

Councilman Forsythe made a motion to appoint Darrel Holdman to serve on the Planning and Zoning Commission, seconded by Councilman Smith, and passed unanimously.

Councilman Forsythe exited the meeting at 7:02 pm.

Councilman Forsythe re-entered the meeting at 7:05 pm.

Councilman Holdman made a motion to approve the consent agenda, seconded by Councilman Kellogg, and passed unanimously.

Councilman Kellogg made a motion for the second reading by title only and Council action on Bill 04012015, seconded by Councilman Smith, and passed unanimously.
