

# CITY OF FARMINGTON

## City Council Minutes of Meeting February 22, 2016 6:30 p.m.

The City Council of the City of Farmington met on February 22, 2016, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Landrum.

Mayor Landrum gave the invocation.

The roll was called with the following Councilmen present: Darrel Holdman, Mark Kellogg, Garrett Boatright, Dennis Smith, John Crouch, John Robinson and Larry Forsythe.

City Counselor, Scott Reid, was present.

Officials present were: Greg Beavers, Rick Baker, Floyd Massey, Todd Mecey, Travis Trokey, Robert Sullivan and Paula Cartee.

Councilman Holdman made a motion to approve the agenda, seconded by Councilman Kellogg, and passed unanimously.

Reports were given by Committee Chairs with discussion.

Rick Baker, Police Chief, gave a 2015 Crime Statistics Report.

Greg Beavers, City Administrator, provided an update and answered questions from the Council.

Councilman Holdman made a motion to approve the consent agenda, seconded by Councilman Kellogg, and passed unanimously.

Councilman Kellogg made a motion for the second reading by title only on Bill 01022016, seconded by Councilman Smith, and passed unanimously.

Counselor Reid read the following Bill once by title only.

**BILL 01022016- ORDINANCE 11-2I 112: AN ORDINANCE AMENDING THE GENERAL ZONING ORDINANCE AND ACCOMPANYING MAP THERETO AND KNOWN AS GENERAL ORDINANCE 11-2I BY CHANGING THE CLASSIFICATION OF THE ZONE DISTRICT FOR CERTAIN PARCELS OF LAND DESCRIBED HEREIN.
