City Council Minutes of Meeting September 26, 2016 6:30 p.m.

The City Council of the City of Farmington met on September 26, 2016, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Landrum.
