

CITY OF FARMINGTON

City Council Minutes of Meeting June 27, 2016 6:30 p.m.

The City Council of the City of Farmington met on June 27, 2016, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Landrum.

Mayor Landrum gave the invocation.

The roll was called with the following Councilmen present: Darrel Holdman, Mark Kellogg, Garrett Boatright, Dennis Smith, John Crouch, John Robinson, Larry Forsythe and Dale Wright.

City Counselor, Scott Reid, was present.

Officials present were: Greg Beavers, Michelle Daniel, Chris Conway, Todd Mecey, Floyd Massey and Paula Cartee.

Councilman Holdman made a motion to approve the agenda, seconded by Councilman Kellogg, and passed unanimously.

Ronald Short, 721 Overton Street, addressed the Council explaining he purchased an above ground pool and is now being told by the City that they can't have the pool on their lot.

Mr. Beavers explained that the pool is considered an accessory structure and doesn't meet the set-backs requirements. He stated that the City has not received any complaints from any residents in that neighborhood. He recommended that Mr. Short be allowed to keep the pool in the current location this summer and address the violations in October. The Council was in agreement.

Stacie Mathews, 509 Center Street, addressed the Council requesting that citizens be allowed to have chickens.

Reports were given by Committee Chairs with discussion.

Larry Forsythe made a motion to install a caution light at Dewey Street and at Murphy Street, seconded by Councilman Kellogg. Seven (7) ayes, and one (1) nay, Motion passed.

Michelle Daniel, Finance Director, gave a financial overview.

Greg Beavers, City Administrator, provided an updated and answered questions from the Council.
