City Council Minutes of Meeting January 12, 2017 6:30 p.m.

The City Council of the City of Farmington met on January 12, 2017 at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Landrum.

Mayor Landrum gave the invocation.

Councilman Holdman made a motion to approve the agenda, seconded by Councilman Kellogg, and passed unanimously.
