City Council Minutes of Meeting March 9, 2017 6:30 p.m.

The City Council of the City of Farmington met on March 9, 2017, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Landrum.

Mayor Landrum gave the invocation.
