City Council Minutes of Meeting May 11, 2017 6:30 p.m.

The City Council of the City of Farmington met on May 11, 2017, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Forsythe.
