City Council Minutes of Meeting July 13, 2017 6:30 p.m.

The City Council of the City of Farmington met on July 13, 2017, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Forsythe.

Mr. Brown gave the invocation.

Councilor Holdman made a motion to approve the agenda, seconded by Councilor Kellogg, and passed unanimously.
