## CITY OF FARMINGTON

City Council Minutes of Meeting August 28, 2017 6:30 p.m.

The City Council of the City of Farmington met on August 28, 2017, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Forsythe.

Councilor Robinson gave the invocation.

The roll was called with the following Councilors present: Darrel Holdman, Mark Kellogg, Vanessa Pegram, Wayne Linnenbringer, John Crouch, John Robinson, Cody Eaves and Dale Wright.

Councilor Holdman made a motion to approve the agenda, seconded by Councilor Kellogg, and passed unanimously.

Nancy Cozean, 117 Ohio Court, addressed the Council extending an invitation to attend the rededication of the Plank Road Marker. She stated it will be held on Saturday, September 2, 2017, at 11:30 a.m. at Long Park.

Reports were given by Committee Chairs with discussion.
