City Council Minutes of Meeting February 8, 2018 6:30 p.m.

The City Council of the City of Farmington met on February 8, 2018, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Forsythe.

Councilor Robinson gave the invocation.
