City Council Minutes of Meeting April 23, 2018 6:30 p.m.

The City Council of the City of Farmington met on April 23, 2018, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Forsythe.

Councilor John Robinson gave the invocation.

Councilor John Robinson made a motion to approve the agenda, seconded by Councilor Holdman, and passed unanimously.

Ewell Lawson, Missouri Public Utility Alliance, presented the City with a grant check for \$135,796.00 to help with costs for the new substation on Woodlawn Drive.

Reports were given by Committee Chairs with discussion.

Councilor Pegram, Public Services Committee Chair, mentioned that the next Public Services Meeting would be held on May 29 at 5:30 p.m. instead of May 28 (Memorial Day).

Greg Beavers, City Administrator, provided an update and answered questions from the Council.
