CITY OF FARMINGTON

City Council Minutes of Meeting June 14, 2018 6:30 p.m.

The City Council of the City of Farmington met on June 14, 2018, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Forsythe.

Don Brown, 46 Veterans Drive, gave the invocation.

The roll was called with the following Councilors present: Darrel Holdman, Tom Joyce, Vanessa Pegram, Wayne Linnenbringer, John Crouch, John Robinson, Adam Parks and Dennis Robinson.

City Counselor, Scott Reid, was present.

Officials present were: Tim Porter, Michelle Daniel, Floyd Massey, Rick Baker, Todd Mecey, Paula Cartee, Ashley Bischoff, Chris Conway and Larry Lacy.

Councilor Crouch made a motion to approve the agenda, seconded by Councilor John Robinson, and passed unanimously.

Cindy Massey, 315 Forster Street, addressed the Council with concerns regarding Elemental CrossFit located at 305 Forster Street. She is concerned with the noise, vibrations, parking and traffic issues caused by the business. She doesn't feel like the gym is compatible with the neighborhood and would like the City to look into the zoning of the building and see what can be done about it.

Councilor Crouch stated that the building located at 305 Forster Street is commercial because it was grandfathered in. He also mentioned that there are parking signs up on a 90-day trial to try to improve the parking situation. If no improvement is made, then the signs will be removed.

Counselor Reid explained that the building is grandfathered in and is considered a Prior Non-Conforming Use, which was in place when the zoning was established. He stated that someone would need to prove that there was no commercial activity at the location for 18 months for the grandfathered status to change. He said that the current problems can't be fixed by zoning because it will not apply to this location. The problem would have to be addressed under another part of the code.

Cindy Massey, 315 Forster Street, asked for suggestions on what route to take.

Mayor Forsythe stated that the Administrative Services Committee would need to get together and talk about the topic. If the committee wanted to make some rules, they would need to bring them to the Council for a vote.

Floyd Massey, 315 Forster Street, addressed the Council with concerns regarding Elemental CrossFit located at 305 Forster Street. He stated that if this were a different type of business and they were conducting business in the street or on the sidewalks, it wouldn't be allowed, but CrossFit is allowed to run up and down the street in front of the houses and block traffic.

Don Brown, 46 Veterans Drive, addressed the Council to thank them for what they have done for Farmington. He stated that he hopes the new council will be as open-minded as the old council.

Reports were given by Committee Chairs with discussion.

Councilor Crouch informed the Council that the Public Works Committee would be taking a "field trip" on June 25, 2018 at 8:00 a.m. to look at different detention ponds around town.

Larry Lacy, Public Works Director, addressed the Council about the detention pond in Autumn Chase Subdivision.

Councilor Pegram stated that she was concerned about the residents having to take care of the detention pond instead of the City.

Larry Lacy responded that the City doesn't care for all detention ponds.

Councilor Crouch asked what the Architectural Preservation Grant money would be used for at 102 West Columbia Street.

Tim Porter, Director of Development Services, responded that it would be used for a roof and tuck-pointing.

Councilor Holdman made a motion to approve the consent agenda; all Councilors were in favor of the approval.
