City Council Minutes of Meeting June 25, 2018 6:30 p.m.

The City Council of the City of Farmington met on June 25, 2018, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640. The meeting was called to order by Mayor Forsythe.

Councilor John Robinson gave the invocation.

Councilor Holdman made a motion to approve the agenda, seconded by Councilor Crouch, and passed unanimously.

Councilor John Robinson made a motion for the second reading by title only of Bill 21062018, seconded by Councilor Pegram, and passed unanimously.


Counselor Reid read the following Bill once by title only.


