

# CITY OF FARMINGTON

## City Council Minutes of Meeting March 25, 2019 6:30 p.m.

The City Council of the City of Farmington met on March 25, 2019, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640.

The meeting was called to order by Mayor Forsythe.

Councilor John Robinson gave the invocation.

The roll was called with the following Councilors present: Tom Joyce, Vanessa Pegram, Wayne Linnenbringer, Edward Felker, John Robinson, Adam Parks and Dennis Robinson.

City Counselor, Scott Reid, was present.

Councilor John Robinson made a motion to approve the agenda, seconded by Councilor Dennis Robinson, and passed unanimously.

Sam Barnhouse, 511 Boyce Street, addressed the Council in regards to the sidewalks on Boyce Street. She stated that she is upset about one side of the street being redone and her side of the street not being touched.

Larry Lacy, Public Works Director, explained how sidewalk replacements are typically handled.

Mayor Forsythe asked that the Public Works Committee make a decision on whether or not to redo the sidewalks on Ms. Barnhouse's side of the street.

Mayor Forsythe announced the dedication of the John R. Crouch Memorial Park.

Reports were given by Committee Chairs with discussion.


Councilor John Robinson made a motion for the second reading by title only of Bill 13032019, seconded by Councilor Dennis Robinson, and passed unanimously.


Councilor John Robinson made a motion to adjourn, seconded by Councilor Linnenbringer, and passed unanimously.
