City Council Minutes of Meeting September 12, 2019 6:30 p.m.

The City Council of the City of Farmington met on September 12, 2019, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640.

The meeting was called to order by Mayor Forsythe.




Adjourn to Closed Session.
