

CITY OF FARMINGTON

City Council Minutes of Meeting September 23, 2019 6:30 p.m.

The City Council of the City of Farmington met on September 23, 2019, at Long Memorial Hall, 110 West Columbia Street, Farmington, Missouri, 63640.

The meeting was called to order by Mayor Forsythe.

Councilor John Robinson gave the invocation.

The roll was called with the following Councilors present: Dennis Robinson, Greg Hampton, Tom Joyce, Vanessa Pegram, Wayne Linnenbringer, John Robinson and Adam Parks.

City Counselor, Scott Reid, was present.

Officials present were: Paula Cartee, Michelle Daniel, Todd Mecey, Greg Beavers, Ashley Bischoff, Travis Trokey, Tim Porter, Larry Lacy, Floyd Massey and Rick Baker.

Councilor John Robinson made a motion to approve the agenda, seconded by Councilor Pegram, and passed unanimously.

Kenneth Smith, 329 Third Street, addressed the Council regarding his neighbor who previously owned Eclipse Trash Service and still has debris everywhere although his trash business has ceased.

Tim Porter, Director of Development Services, explained that the code enforcement officer has made contact with the resident and is in the process of trying to resolve the issue.

Carmen Pirtle, 712 E Columbia Street, addressed the Council regarding trouble with her mother's neighbor (previous owner of Eclipse Trash Service) taking over her side of the shared driveway. She stated that the neighbor has been parking in her mother's driveway due to his trashcans taking over his side of it.

The Council agreed for a letter to be sent from the City to the neighbor, Jimmy Cook, requesting his consent for the City to remove the nuisance at his expense.

Christopher Massey, 400 N Washington Street, Suite 232, addressed the Council to inform them of the new services that Presbyterian Children's Home and Services (PCHAS) is providing to the community.

Reports were given by Committee Chairs with discussion.

Michelle Daniel, Finance Director, provided a financial overview.

Greg Beavers, City Administrator, provided an update and answered questions from the Council.

Councilor John Robinson made a motion to approve the consent agenda, seconded by Councilor Pegram, and passed unanimously.

BILL 29082019-ORDINANCE 11-677: AN ORDINANCE OF THE CITY OF FARMINGTON, MISSOURI, APPROVING AND ACCEPTING A FINAL RECORD PLAT AT 217 HILLSBORO ROAD. BILL 30092019: AN ORDINANCE OF THE CITY OF FARMINGTON, MISSOURI, AMENDING THE GENERAL ZONING ORDINANCE AND ACCOMPANYING MAP THERETO AND KNOWN AS GENERAL ORDINANCE 11-21 BY CHANGING THE CLASSIFICATION OF THE ZONE DISTRICT FOR A CERTAIN PARCEL OF LAND DESCRIBED HEREIN. (1105 WEBER ROAD)

Councilor Joyce made a motion for the first and second reading by title only, including the amendment noted by Finance Director, Michelle Daniel, of Bill 31092019, seconded by Councilor Pegram, and passed unanimously.

Counselor Reid read the following Bill twice by title only.

BILL 31092019-ORDINANCE 13-40AA: AN ORDINANCE OF THE CITY OF FARMINGTON, MISSOURI, APPROVING AND ADOPTING A SECOND AMENDMENT TO THE FISCAL YEAR 2018-2019 BUDGET AND AUTHORIZING THE EXPENDITURES CONTAINED THEREIN. Councilor Joyce made a motion for the first and second reading by title only of Bill 32092019, seconded by Councilor Pegram, and passed unanimously.


Counselor Reid read the following Bill twice by title only.

Councilor John Robinson made a motion to adjourn, seconded by Councilor Pegram, and passed unanimously.


